WHEREAS, consonant to the thrust of the national government in agriculture, the **Department of Agriculture** has adopted the **Philippine Rural Development Program (PRDP)** with the end in view of improving the income and food security of the rural poor and indigenous communities of the Philippines;

WHEREAS, the provincial government deems the **DA's** project a very laudable one, therefore, this August Body confers authority to the **Honorable Governor Faustino "Bojie" G. Dy III** to enter into a **Memorandum of Agreement (MOA)** with the Department of Agriculture specifically for this said project;
