

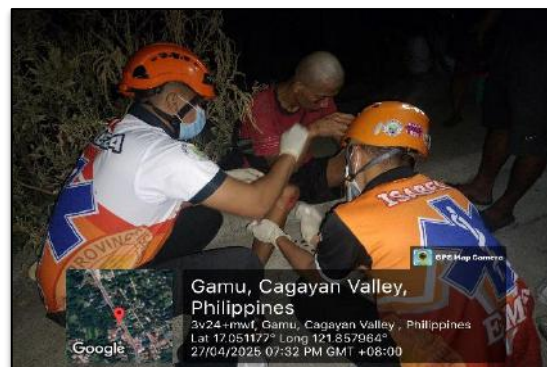

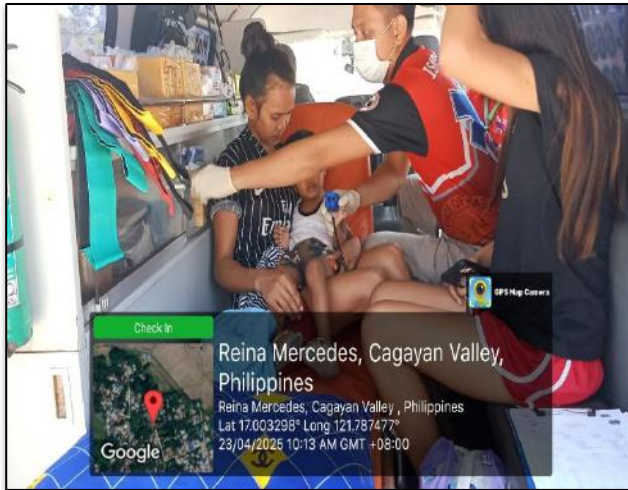

The patient was conscious he suffered laceration on the forehead approximately 1 inch. After the Emergency Care Assistants (ECA) interventions, the patient was immediately brought to GFNDY Sr. Memorial Hospital for proper disposition.



Team responded a **Trauma Incident** at Brgy. Guibang, Gamu Isabela last **April 27, 2025**. The patient suffered laceration wound at right cheek, multiple abrasion upper and lower extremities. Driving under influence of liquor as verbalized by the patient. 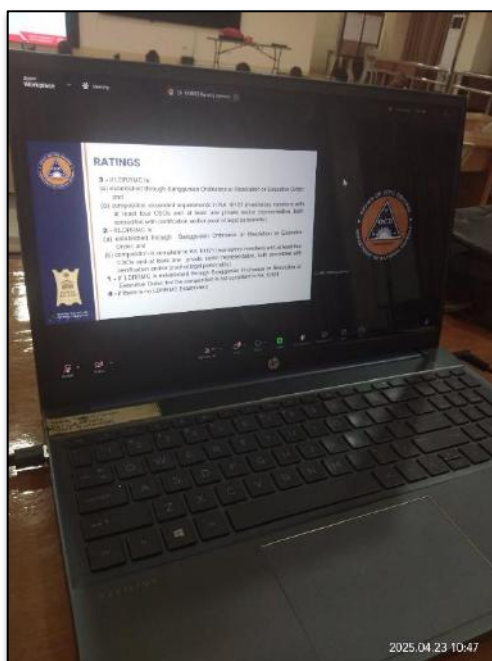
