MONTHLY ACCOMPLSHMENT REPORT

For the month of March, 2014

I. REVENUE GENERATION AND RESOURCE MOBILIZATION PROGRAM:

- 1. Issued the following as required by the Bureau of Internal Revenue (BIR), Department of Agrarian Reform (DAR), other lending institutions and other interested parties upon verification from our existing records and payment of fees and charges to the Provincial Treasurer's Office;
 - 1. 72 certifications relative to real property assessments
 - 2. 131 certified copy of Tax Declarations
 - 71 certified photocopy of Tax Declaration (TD), and other assessment records
- 2. Received two (2) Petitions Re- Issuance of another Owners Duplicate Copy, issued by DAR, Isabela Provincial Office, San Fermin, Cauayan City, and four (4) Sheriff's Notice of Extra Judicial Sale under ACT 3135 as amended by ACT 4118 from RTC Second Judicial Region, Office of the Clerk of Court, Branch 17, Ilagan, for postings of which it were simultaneously posted in our bulletin board and certifications were issued after the prescribed posting period.
- 3. Received three (3) request for annotation of encumbrance on the face of Tax Declaration and simultaneously annotated in our records based from mortgage contract issued by banks and bail bond issued by court and certifications were being issued confirming the encumbrances made.

Approved assessment transactions submitted/recommended for approval by the Municipal Assessors of the thirty four (34) Municipal Assessor's Offices, this province, upon proper review and verification of personnel concerned, whether assessment procedures and techniques were being followed, to wit;

 - b) 258 RPU's on subdivision/consolidation/revision or with physical changes (PC)
 - c) 546 RPU's on transfer of ownership
- 5. Returned a total of fourteen (14) RPU's of deficient assessment transactions to Municipal Assessors concerned informing them the deficiency of their transactions which needs to be complied with, to facilitate its approval.

Jucar, Draftsman I, both of this office were delegated to coordinate with the National Grid Corporation of the Philippines (NGCP) to secure inventory of total number of transmission Lines, installed along the vicinity of the province of Isabela, likewise to coordinate with Local Assessors for the declarations of Transmission Towers in the name of National transmission corporation (NTC) in their respective area of jurisdiction.
