FOREST MANAGEMENT AND CONSERVATION DIVISION

I. NURSERY OPERATIONS & MAINTENANCE

Three (3) nurseries are being maintained by the Office, namely: the Provincial Nursery, the Mega Nursery and Lagis Refo Nursery located at Capitol Compound, Villa Imelda and Sitio Lagis all in the City of Ilagan, Isabela. Said nurseries were being manned by a regular and contractual laborers and assisted by the ISEP-TF operatives from time to time as the need arise.

Seedling Production/Stocking:

From January 2017 to December 2017, a total of 48,450 assorted fruit and forest tree seedlings both sexually and asexually propagated including the bamboo propagules (charged out of the LDRRM Fund for our climate change mitigation and adaptation measures) were procured and produced and taken cared of at the Main Provincial Nursery to include the 15,330 remaining stock balance from 2016. A total of 25,342 assorted seedlings were disposed and distributed to different public and private entities such as Municipal and Barangay LGUs, Farmers' Congress, POs/NGOs/Coops, schools, other government agencies like the Philippine Army and Philippine National Police in support to our greening and riparian activities. It also caters the planting materials used in the implementation of the different projects of the Office such as tree parks establishment, riparian development, pollution control measures thru roadside planting, rehabilitation of mined-out sites, Farmers' Congress, Aral Kalikasan sa Eskwela at Barangay and other tree planting activities conducted by the Provincial Government within the Capitol premises. The remaining seedling stock balance as of end of December, 2017 is 27,298 compose of 14,515 fruit-bearing tree seedlings, 2,223 forest tree seedlings, and 10,560 bamboo propagules. However, due to some unavoidable circumstances such as dumping off caused by excessive rains and flooding of pot beds, we incurred around 17% mortality rate equivalent to 11,140 assorted seedlings.

The Mega Nursery at Villa Imelda has no permanent laborers assigned for its continuance hence some of the ISEP-TF assigned at Abuan Checkpoint from time to time did some maintenance works therein. About **500** acasia (samanea saman) seedlings were delivered and planted at the IDRRIP reforestation site, but during the summer season when there was no enough supply of water, the remaining stock of forest tree seedlings has dwindled and the rest were eaten by rats.

Lagis Reforestation Nursery is being improved to ensure that planting stock for the numerous tree planting activities is sustained in support of the Ilagan-Divilacan Road Rehabilitation and Improvement Project (IDRRIP). Hence, the Office, thru the Forestry Unit requested for the assistance of the Engineering Office in the preparation of Budget Estimates for the installation of appropriate water system. As of October 2017, said estimates were

already done and materials for the water system were purchased and delivered in the same month and hopefully to be installed the soonest possible time.

A total of **40,032** narra and **173,472** seedlings of other premium and indigenous species were purchased thru the IDRRIP fund out. To date, a total of **90,428** seedlings were already planted within the reforestation project area which include the **63,615** seedlings planted on the year **2016** and **26,813** seedlings planted for **2017**. Because of unpredictable weather conditions and lack of sufficient water supply especially during the summer months, we incurred **18.27%** mortality rate. The remaining stock balance at the Lagis nursery as of end of December 2017 is **84,069** seedlings of narra and other premium species.

II. FOREST PROTECTION AND LAW ENFORCEMENT

As mandated by existing laws and duly sanctioned by Executive Order No. 03, series of 2014, the ISEP-TF Operatives were able to accomplish their mandated tasks and assisted as well in the implementation of the different projects and activities, to wit:

As of end of December, 2017, a total of 1,119 pieces of different species of woods (Lumber and Flitches) with a total volume of 20,582.00 board feet were apprehended in the conduct of forestry law and enforcement activities. These apprehended lumbers & flitches are under the custody of PGI-ENRO and 12 cases were filed for violation of Section 77 of PD 705, as amended by E.O. 277.

Further, a total of **338 pieces** with a volume of **4,830.21 board feet** apprehended CHW lumbers are under the **custody of PNP San Pablo and CENRO San Isidro.**

In addition to their mandated tasks, the ISEP-TF Operatives actively took part in the effective and efficient implementation of the different forest, mining and environmental programs and projects as follows:

- 1. Manning and maintenance of the eight (8) checkpoints at 24/7;
- 2. Conduct of surveillance activities, foot and mobile patrol in their assigned area of jurisdiction;
- 3. Acted and responded on tipsters' (SMS) reports regarding violation of PD 705;
- 4. Assisted in the operation and maintenance of the Mega and Sitio Lagis Nurseries:
- Conduct tree marking of the affected trees along the Ilagan Divilacan Road Rehabilitation and Improvement Project (IDRRIP);
- 6. Inventory of drifted logs brought by Typhoon Lawin at Bintacan, Cab. 14-16 and Ballacong last January 2-3, 2017;
- Preparation of tree guards during the tree planting activities for Miss Earth first in Sitio Lagis, then in Abuan Agta Village and finally in front of Balai, Provincial Capitol, Alibagu, City of Ilagan, Isabela last January 2017;
- 8. Assisted in the different tree planting activities at IDDRIP Reforestation Area;
- 9. Inventory of illegal settlers allegedly conducting land clearing/kaingin at City of Ilagan and San Mariano, Isabela.
- 10. Take part in the conduct of Dental, Medical and Feeding Programs at Sindun Bayabo, City of Ilagan in support to IDDRIP last March 22 23, 2017;
- 11. Implementation of Ordinance No. 05, series of 2014 of the Provincial Government of Isabela;
- 12. Clean Up Drive activities in different barangays;
- 13. Information, Education and Communication (IEC) Campaigns in the implementation of Ordinance 05, series of 2014, forest protection, proper solid waste management and other environmental awareness advocacies;
- 14. Resizing and transporting of cut trees affected by IDRRIP from the log pond area to Provincial Gymnasium with a total of **1,714 pieces** with approximate volume of **43,005.33 bd.ft.** as of end of December, 2017;
- 15. Monitoring, site inspection and validation of existing commercial sand and gravel and earth moving operations; and
- 16. Roving activities to detect illegal logging, mining and other forestry and mining violations committed by environmental perpetrators.

III. FOREST LANDSCAPE RESTORATION THRU THE ISABELA GREENING PROJECTS

1. Reforestation, Enrichment Planting and Agroforestry Development Activities

a. Reforestation and Enrichment Planting

The Provincial Government of Isabela (PGI) thru its Forestry Unit had been continuously implementing the reforestation component of the Ilagan-Divilacan Road Rehabilitation & Improvement Project (IDRRIP). With assistance from CM Pancho Construction, the Forestry Unit together with ISEP-TF at Sitio Lagis Base Camp conducted site preparation activities such as brushing, hole digging, staking, and others in the reforestation areas to include nursery works. As of reporting period, the Forestry Unit with the help of various stakeholders in the conduct of tree planting activities, a total of **26,813** assorted indigenous forest tree seedlings with an aggregate area of **68.0** hectares.

b. <u>Maintenance of the Agroforestry SALT Project</u>

In support to the National Greening Program of the government, the Provincial Government of Isabela thru this Office being its implementing arm on ENR concerns, has been actively advocating/encouraging constituents conduct its to greening activities agroforestry, reforestation and farm forest establishment to help abate the worsening scenario on climate change and global warming.

Our technical field personnel have been busy conducting inspection and verification survey of areas that were identified as potential sites for greening activities such as the application of agroforestry – the combination of agri-crops/fruit-

bearing trees with forest tree species. As a result and based from their recommendations, the office has extended assistance thru the provision of **4,122** assorted fruit and forest tree seedlings to the different schools, LGUs, and other institutions including private entities for the establishment of their agroforestry farms with an estimated area of **10.2 hectares**. Some of the noted beneficiaries for agroforestry were residents from Sindon Bayabo in the City of Ilagan being the recipients of **1,000** assorted fruit-bearing and forest tree seedlings planted in their hilly lands.

2. Coastal Resources Development and Management thru Beach Forest and Mangrove Rehabilitation

In support of our development endeavors particularly to our coastal areas is the rehabilitation of mangrove areas in the Municipality of Palanan. Through consultations with our counterpart from the LGU-MENRO, five (5) hectares has been identified along the mangrove areas in Sitio Sabang, Barangay Maligaya will be rehabilitated thru enrichment planting (2 hectares for beach forest rehabilitation thru planting of botong and talisai and 3 hectares mangrove using bakawan species).

3. Riparian Project Development

Thru letters of requests, the Local Government Units of Santo Tomas, Quirino and Palanan has signified their interest to plant bamboo propagules along their creeks and river banks for erosion and flood control measures, and thus, include in target areas for riparian development. Not only bamboos but to plant forest and fruit-bearing trees as well both for bank protection/stabilization and aesthetic purposes. The initial target is 2 linear kilometers each for Santo Tomas and Quirino and 1 linear kilometer

specifically in Dibenbinan River of Barangay Dimaliculicu, Palanan to be planted with palm, bignay and bayog.

LGUs Quirino and Palanan were able to accomplish the target riparian sites of 3 linear kilometers, respectively. However, the Local Chief Executive of Santo Tomas has suggested that bamboo planting in their proposed riparian site is yet to be implemented soon as the weather permits. Hence, to complete our target area, we coordinated with the City ENRO of Ilagan and jointly identified Cabisera 8 (Brgy. Sta. Maria) as additional area for riparian development. So in coordination and partnership with the Barangay Officials of Cabisera 8, we were able to initially plant the 1 linear kilometer along Pinacanauan River with bamboo propagules.

4. Urban Greening/Tree Parks Establishment

For the urban greening and tree parks establishment, we conducted initial coordination with the LGU officials for implementation specifically with LGU Delfin Albano and Alinguuigan 1st Elementary School in the City of Ilagan. Initially, 2 hectares were planted with assorted forest tree seedlings along the perimeter of the LGU Sanitary Land Fill located at Barangay Carmencita, Delfin Albano in partnership with the Municipal LGU. The tree planting activity was jointly undertaken with ENRO personnel and ISET-TF Operatives simultaneously in celebration of the Civil Service Month spearheaded by LGU Delfin Albano. Another site established for urban greening is within the 150 linear perimeter of the Agta Village at Cabisera 10, City of Ilagan planted with narra, molave and assorted fruit-bearing tree seedlings.

5. Watershed Rehabilitation

While we are still in the process of identifying specific watershed areas for rehabilitation, we are providing/extending technical assistance as members of the Pasa Small Reservoir Irrigation Project (SRIP) Inter-Agency Council - Technical Working Group (IAC - TWG) in the preparation and development of its Watershed Rehabilitation component and implementation thru forest landscape restoration approaches such as reforestation, agroforestry, enrichment planting and riparian along the dam's rim banks for protection and stabilization. Our Office assisted in the implementation of the Pasa SRIP Watershed Project Component originally with an area of **174 hectares** but as per revised survey result, it was reduced to **159.35 hectares**. Continuous meeting and coordination and provision of technical assistance is being undertaken with our NIA-IMO counterparts in the implementation of the watershed project. As of this year's accomplishment, **46 hectares** has already been planted with assorted forest trees under its reforestation sub-component.

IV. INVENTORY OF FOREST OCCUPANTS

The Forestry Unit together with the ISEP-TF Operatives at Patrol Base Camp in Sitio Lagis, DENR-CENRO Naguilian counterparts, City and Municipal ENROs of Ilagan and San Mariano conducted initial Census/Inventory of illegal settlers who made their kangin/clearing of portions of the forest lands along and within the vicinities of the Ilagan-Divilacan Road Rehabilitation and Improvement Project (IDRRIP).

Through the intensive monitoring and patrol activities of the ISEP-TF, the alleged kaingin activities of the illegal settlers coming from the province of Quirino were immediately concurred. Immediately, the Team coordinated such allegations with Barangay Captain Carlina R. Gabriel of Sindun Bayabo where the said kaingin activities were being done.

Accordingly, as per investigation made by the Team, a certain person and former resident from Cabarroguis, Quirino named Jimmy C. Sebastian and now residing at Sitio Fugu, Sindon Bayabo sold portions of the forest lands to some individuals from Quirino Province. These areas are situated along vicinities of the road (IDRRIP) being constructed. The initial list inventoried by the Team consists of **12 individuals.**

Another site where we conducted inventory of forest occupants is within the ISF Project area in Bubug, Sto. Tomas, Isabela. We were able to list down around **40 individuals** occupying certain portions of the forest lands without tenurial instruments while most of the ISF Project beneficiaries already have their expired Certificate of Stewardship Contract Agreements.

V. CERTIFICATE OF STEWARDSHIP CONTRACTS (CSC) ASSESSMENT AND EVALUATION

Through the devolved Integrated Social Forestry (ISF) Program, the issued Certificate of Stewardship Contracts (CSC) to the ISFP beneficiaries of Barangay Aguinaldo, Ramon and Barangay Quirino, Cordon has been assessed and evaluated by the team composed of representatives from this Office, DENR-CENRO San Isidro and the Municipal LGU of Ramon. Initially, the team was able to accomplish a total of **47 CSC holders** in the said ISF Project sites but only **4 CSC holders** from sitio Imistampa, Quirino, Cordon, Isabela were officially submitted by DENR-CENRO San Isidro to the DENR Regional Office. Based from the result of the assessment and evaluation, majority of the CSCs were already expired and the holders are no longer the actual occupants/tillers. The ISF farm lots were then waived to the actual occupants by the CSC holders.

ENVIRONMENTAL MANAGEMENT DIVISION

I. PROVINCIAL ECOLOGY CENTER/SOLID WASTE MANAGEMENT

The Provincial Ecology Center showcases good practices compliant to the provisions of RA 9003, otherwise known as the Ecological Solid Waste Management Act. The practice of waste segregation at source in every office is implemented in the whole provincial capitol premises through the imposition of Sangguniang Panlalawigan Ordinance No. 1, series of 2017. The Center is utilized as a multi-purpose facility for conferences and warehousing of other facilities extended to lower local government units.



II. ORGANIC FERTILIZER PRODUCTION THRU VERMI-COMPOSTING FACILITY

A system of collection is supervised by the Environmental Management Division Staff with tow service providers in the reduction of waste through vermin-composting, thus a production of 12,440 kilograms of high grade organic fertilizer from waste recycling and composting for this year 2017. A total of 7,310 kilograms were disposed mostly used during the series of tree planting activities of the provincial government. As of December 29, 2017, 5,130 kilograms is currently available at the ENR Office ready for disposal. The production area within the Provincial Ecology Center is a 500-square meter area for the production of vermi-compost and composting facilities.



III. SEARCH FOR RA 9003 COMPLIANT BARANGAYS

To promote a common understanding on the implementation aspect of RA 9003, the provincial government is set to conduct it first Search for RA 9003-Compliant Barangays. This aims to encourage environmental advocacy as a means to mitigate the ill effects of climate change through a doable collective and participatory efforts of all stakeholders' right in the barangay levels. In coordination with the different City/Municipal ENR Officers thru the Philippine League of Local Environment and Natural Resources Officers (PLLENRO) Isabela Chapter, the search criteria were crafted subject for the approval of the Local Chief Executive together with the project proposal. Said proposal was duly approved with the amount of Seven Hundred Fifty Thousand. The subject activity proposal will run for a period of two semesters beginning 2nd semester of 2017 to 1st semester of 2018.





Upon approval of the criteria, the ENR Office together with PLLENRO Isabela Chapter conducted a meeting to inform the cities and municipalities thru their municipal counterparts on the updates on the schedule of the Search implementation.





IV. UPDATES ON THE 10-YEAR PROVINCIAL ESWM PLAN

In support to City/Municipal Local Government Units, the PGI thru the ENR Office has extended technical and material assistance in their conduct of Waste Analysis and Characterization Study (WACS). Said study is the most vital information needed in preparation of their 10-year ESWM Plan as mandated by RA 9003 otherwise known as the Ecological Solid Waste Management Act of 2000. Hence, was able to assist lower LGUs mostly under the 3rd and 4th class municipalities in collaboration with the EMB and DILG. Corollary, the PGI has formed and adopted its 10-year Provincial ESWM Plan.

Simultaneously to the updating of the Provincial 10-year ESWM plan, the ENR Office monitored the compliance of LGUs in their writing and submission of their individual 10-year ESWM Plans to further extend possible assistance needed for their compliance. On February 2017, the PGI thru the ENR Office has conducted the 2nd Provincial ESWM Summit with the aim to strengthen the barangay and municipal LGUs in their commitment to comply with the requirements of RA 9003.

Duly adopted on October 24, 2017, the approval of said Plan is another milestone in the implementation of programs and projects all geared towards responsive management of Isabela's life support systems.

V. STATUS REPORT ON THE PROPOSED SANITARY LANDFILL (SLF) CLUSTER II


In support to the Clustered Sanitary Landfill with Pilot Project site at San Manuel, Naguilian, Isabela, the Office is currently complying with the requirements set forth by the Department of Environment and Natural Resources. As the implementing arm of the PGI, the ENR Office initiated the conduct of meeting/dialogue with the clustered municipalities under District 2. As of June, 2017, regulatory requirements and technical documentation mandated by DENR-EMB policies specifically consultation meetings with the cluster members, IEC and ECC requirements have been accomplished. These were prepared thru series of actual conduct of existing household inventory at the proposed site, public consultation to the direct impact areas and the member-municipalities of the cluster.

✓ Pollution Control Measures

In recognition of the environmental consequences of transportation sector development to the ecosystems management, the Provincial Government of Isabela thru the Environment and Natural Resources Office has identified the implementation of pollution control measures thru the conduct of road side planting for carbon sequestration and assure its maintenance in coordination with its partner LGUs and/or agencies. With approved proposal amounting to One Hundred Forty Three Thousand Two Seventy One pesos and 80/100 (P143,271.80), the project shall be implemented to three (3) identified sites with a total length of 7.1 kilometers, namely: Carmencita, Delfin Albano; Cansan, Cabagan; and Calamagui, San Pablo.

In coordination with the Local Government Units, both barangay and municipality, site preparation activities were supervised and conducted. As of October, 2017 the road side planting was already conducted at Cansan, Cabagan and Carmencita, Delfin Albano on October 27, 2017 and October 28, 2017 respectively. On the other hand, Calamagui, San Pablo road side planting is set to be conducted on November 9, 2017.

VII. REHABILITATION OF MINED-OUT SITES THRU MINERAL RESOURCES FUND (MRF) UTILIZATION

To sustain and maintain an ecological balance between resource utilization and environmental protection, the provincial government thru the ENR Office has implemented Riverbank Stabilization Project thru the utilization of Mineral Resources Fund, a fee collected purposely for rehabilitation projects of mined-out sites.

With an approved project proposal amounting to One Hundred Eighty Eight Thousand pesos (P 188,000.00) only, a total of Seven (7) kilometers at two (2) strips per kilometer was set to be rehabilitated thru planting of bamboo propagules and mahogany seedlings. As of December 29, 2017, five (5) kilometers at two (2) strips per kilometer riverbanks were already planted specifically at the mined-out sites located at the following, to wit:

III. ENFORCEMENT OF MINING AND QUARRYING LAWS AND ORDINANCES

The Office conducted regular monitoring of all mining and quarry areas regarding strict enforcement and implementation of Provincial Ordinance No. 5, series of 2014. Strong partnership with LGUs having sand and gravel extraction activities is manifested thru continuous dialogues and meetings together with the permittees and operators. Regular monitoring of delivery receipts and submission of reports as required by the Ordinance is being complied with and regularly counterchecked by our field officers.

1. <u>Site Verification and Inspection of Mining/Quarry Sites</u>

Quarry Inspection - Field verification was conducted by ENR personnel at the applied quarry areas of permittees within the province. The inspection aims to validate the quarry areas based on survey plans submitted to this office.


Field Monitoring of Quarry Areas

Teams from the ENRO Personnel and Isabela Environment Protection - Task Force (ISEP-TF) were dispatched to conduct regular monitoring, field inspection and verification of sand and gravel extraction activities within the twenty two (22) municipalities covered by forty five (45) barangays. These quarry areas were being operated by thirty one (31) permittees. The team also assisted the PTO in the collection of fees and taxes due to the province.

Monitoring of sand and gravel extraction activities were conducted thru the use of reports, daily monitoring forms and delivery receipts regularly submitted to the Office by the checkers. Upon reconciliation, said records were forwarded to the Office of the Provincial Treasurer. For 2017, a total volume of Seven Hundred Thirty Four Thousand Six Hundred Seventy Two and 72/100 cubic meter (734,672.72 cu.m.) of mineral and quarry resources were extracted with corresponding gross tax payment collected amounting to Twenty Eight Million Five Hundred Ninety Five Thousand Three Hundred Sixty and 15/100 Pesos (Php 28,595,360.15).

Monitoring of Minahang Bayan in Dinapigue

Regular monitoring on status/activities of the Minahang Bayan area located at Sitio Dimakawal, Bucal Sur/Bucal Norte, Dinapigue, Isabela by were being conducted **ENR** Personnel. Together with the DENR, Municipal LGU, PNP, BLGU, and other stakeholders, the team conducted series of ocular inspections in the area to prevent illegal mining activities that may sometimes occur.

On March 13-17, 2017, the ENRO Personnel conducted field validation on the alleged siltation of Ditapigue River caused by quarry/mining activities at the proposed Minahang Bayan. Based on report submitted, equipment were observed which used on the ongoing rehabilitation proposed of the Minahang Bayan and evidence of extraction of resources, newly removed ball-mill machine and old stockpiles and the team also observed that the creek located near the Minahang Bayan is connected to Ditapigue River and can

possibly causes siltation especially during heavy rains. Hence, it was recommended to immediately put-up silt ponds/protective barriers along the Minahang Bayan area to avoid possible siltation of Dinapigue River.

On May 30 to June 3, 2017, the ENRO Personnel together with DENR-MGB representative conducted validation of the reported stockpile of mineralized materials. As per validation there were 3 stockpiles of mineralized materials observed with a total volume of 10,800 cu.m. the team also recommended the conduct of metallurgical analysis to determine the economic value of said stockpiles.

2. Conflict/Dispute Resolutions

a. Alleged Illegal Quarrying Activities

Paculagu Creek, Cabagan and Sta. Maria

In response to a letter received by this office from concerned citizens living near the Paculagu Creek regarding alleged quarrying activities along the said creek. ENRO personnel concerned conducted inspection and investigation and based on the investigation conducted, traces of quarry operations were observed equipment

were also present during the investigation. Quarry operators were identified as Mr. Reynaldo Atuan and Northern Luzon-Golden Rabbit Corporation. The team then contacted said operators and advised them to refrain from their quarrying operations. Moreover, office issued Cease and Desist Order to the identified operators since there was no applied Commercial Sand and Gravel Permit in the area.



San Mateo, Isabela

In response to the letter of Hon. Crispina Agcaoili, Municipal Mayor of the Municipality of San Mateo requesting this office to conduct ocular inspection of the different commercial sand and gravel (CSAG) areas located within their jurisdiction. ENRO personnel concerned together with MLGU representatives conducted inspection of quarry areas. Based on the inspection report, quarry operations where observed at CSAG areas of Barangays Sinamar Norte, Old

Centro Proper, Mapuroc and San Roque. However, permit holders of said CSAG areas failed to renew their CSAG permits during the time of inspection. Hence, the office issued Stoppage Order to quarry operators until they comply with the requirements stipulated under Ordinance No. 05 series of 2014.

Aurora, Isabela

In response to the verbal instruction of ENR Officer regarding the temporary suspension order issued by the Hon. Mayor, William T. Uy dated October 5, 2017 on the quarry operations within the Municipality of Aurora, Isabela, ENRO personnel concerned together with the LGU representative conducted inspection of quarry sites at Barangays Panecien, Saranay, Macatal, Kalabasa, Sili, San Pedro, San Pablo, and Apiat. As a result of

the inspection, it was found out that there were no extraction activities at Barangay Panecien. After the conduct of site inspection, the team had a dialogue with the Honorable Mayor where he explained the rationale of his issuance of Executive Order No. 7, series of 2017. In conclusion, the team advised the contractors and haulers to temporarily stop and for Aurora Employees Multi-Purposed Cooperative as permit holder to make reconciliation of records.

b. Dialogue with Municipal LGU and Stakeholders

Delfin Albano, Isabela

In compliance to travel Order Nos. 1289 and 1290, the ENR Officer and staff proceeded to Delfin Albano, Isabela to attend dialogue relative to the identification of proposed site for quarry area as per request of Hon. Arnold P. Co, Municipal Mayor of said town. The main discussion was on possible quarry areas being proposed by the Barangay



Captains for applications. Mayor Co requested the assistance of ENRO to conduct field inspection of the proposed areas hence, ENRO PERSONNEL together with the MPDC, Municipal Engineer and Barangay Captains proceeded to the said areas for inspection.

Benito Soliven

In compliance to the invitation dated October 9, 2017 to attend meeting conducted by Sangguniang Bayan Committee on October 11, 2017 regarding quarry activities within their jurisdiction. The committee read the complaint letter of the 100 complainants regarding the quarry operations at Purok 2,



Yeban Sur and claimed that it can potentially damage their farm lots nearby. The committee chair asked the ENRO representative if there is/are quarry permit issued within their jurisdiction. ENRO Personnel reiterated that there was no quarry permit issued within the municipality but some person had paid pre-payment (quarry taxes) to the PGI. The committee then decided to conduct actual inspection to the area to validate the complaints and recommend the temporary stoppage of quarry operations at the said area to their regular SB Session and to the Municipal Mayor.

Dinapigue, Isabela

In compliance to Office Order No. 7128 dated October 19, 2017, the ENR Personnel proceeded to Dinapigue, Isabela in response to the letter of the Hon. Samuel P. Cariňo, Liga na Mga Barangay President dated October 12, 2017 concerning the mining operation at Sitio Dimakawal. The ENR Personnel discussed updates and answered issues/concerns of



residents pertaining to the proposed Minahang Bayan during the 3-day assembly meetings scheduled as follows:

Among of the issues and concerns raised include updates as to when will be the operation since they are always informed that it will soon start, what is the basis of the operation currently conducted at Sitio Dimakawal; and how are taxes computed. These issues were answered by the ENR Officer explaining to them that the application of the province for the declaration of the 164 hectares Minahang Bayan at Sitio Dimakawal, Bucal Sur/Bucal Norte was delayed due to the change of national leadership particularly of the DENR where mining became the least priority. As of October 16, 2017 the PLGU was informed by MGB-R02 that the application is now at the Office of the DENR Secretary for his appreciation and approval thus the exact date of the operation cannot be determined yet. However, they were given assurance that upon approval, the operation shall start immediately giving priority to the small scale miners of Dinapigue. As for the basis of the current operation in the concerned area, the ENR Officer stressed that the operator was issued Quarry Permit as stipulated under the Provincial Ordinance No. 5, series of 2014. Further, the issuance of the Permit was based on the submitted documents as required by the provincial ordinance. He then invited those with questions on the issuance of said Permit that the ENR Office is very open for the viewing of documents concerning the issue. On the other, the taxes paid by the permittees are computed as follows: 40% for the Barangay, 30% for the Municipality and 30% for the Province. In addition, a Mine Rehabilitation Fund is also collected purposely for rehabilitation activities only and can be utilized upon request subject to the submission and approval of a project proposal.

3. <u>Provincial Mining Regulatory Board (PMRB) Meetings</u>

As member of PMRB, this office joined the four (4) regular meetings this year to settle issues and concerns regarding the utilization of mineral resources in the province and to evaluate & endorsed CSAG application permits and other permits to the Provincial Governor for his approval.

During the third regular meeting conducted last October 23, 2017, the PMRB decided not to endorse Permit Applications without complete documents/requirements especially an approved Environmental Compliance Certificate from DENR-EMB. Further, the office advised those quarry permittees to refrain from quarry operations until they comply with the necessary requirements.



The PMRB also conducted a special meeting last December 21, 2017 at the MGB Region 02 Office, Tuguegarao City purposely for the discussion and settlement on the request for the release of Environmental Guarantee Fund (EGF) of Small Scale Mining Permit Holders with areas located at Batong-labang, City of Ilagan, Isabela. Upon presentation of the result of the conducted site assessment, the Board came up with Resolution No. 05, series of 2017 endorsing to the Provincial Governor for his appropriate action the request for the release of the EGF.

4. <u>Field Identification, Assessment and Verification of Proposed Minahang Bayan</u>

As approximate area One Thousand Four Sixty Five Hectares (1,465 ha) was identified, assessed and verified for the proposed Minahang Bayan Sitios Dipogo, Dingading and Jet at Barangays Rizal and Dicamay ,San Guillermo, Isabela.

From the initial start of our forest landscape restoration activities in support of the IDRRIP in 2016 to present, we were able to plant a total of **90,428** assorted species of indigenous forest tree seedlings with aggregate area of **128** hectares. The ratio of trees cut and seedlings planted is at 1:51.

In addition, monitoring of planted seedlings is being done from time to time by Forestry Unit and ISEP-TF Operatives assigned at Sitio Lagis Patrol Base Camp to ensure higher survival rate.

Part of our community-based development activities being undertaken for the improvement of the people's livelihood in Sitio Lagis is the provision of technical assistance and planting materials such as fruit-bearing tree seedlings to be planted alongside their agricultural crops for slope protection and soil and water conservation measures thru adoption of the Sloping Agricultural Land Technology (SALT) suitable for their sloping and hilly areas.

2. Environmental Compliance Certificate Monitoring

The 1st Multi-partite Monitoring Team (MMT) field activity was conducted last January 26-27, 2017 attended by members of the MMT coming from different agencies led by DENR RO2-EMB. The team was able to come-up with Compliance Monitoring Validation Report which was then submitted to the **DENR-EMB** Regional Office No. 02. Moreover, The ECC compliance team was tasked to ensure that the proponent and the contractor are complying with the terms and conditions specified in the ECC. As of to date, the PGI had also submitted Compliance Monitoring Report of the

project to the DENR-EMB Region 02 covering the period from January to June, 2017.

3. Disposition of the Cut Trees along IDRRIP

The affected trees that were cut during the construction activities were stored at the designated log pond area at km 21. Recovery of the logs that were still found along the road is on-going and transporting it to the log pond area. And since the logs were now on its degenerative condition, there is already the need to dispose such forest products before losing its economic value. Hence, in a special meeting initiated by the Provincial Government and recommended by the Regional Multi-Forest Protection Committee (RMFPC) during their first round of field visit and monitoring at the IDRRIP attended by concerned agencies including the DENR, it was decided that a Memorandum of Agreement (MOA) between DENR and PGI pertaining to the resizing and transporting of the logs to the official depository for proper evaluation and turn-over should be done. And the said MOA was already signed by the Provincial Governor and the DENR-PENR Officer.

Hence, resizing and transporting of lumber from the log pond area to the official depository is currently being undertaken. As of end of December, 2017, the total volume of the **1,714 pieces** lumber that was already delivered to the depository is **43,005.33 board feet.** Moreover, the identification of priority schools as beneficiaries specified in the Special Tree Cutting and Earth Balling Permit (STCEBP) is on-going in close coordination with the Department of Education officials in the province of Isabela.

4. Continuous Inventory of Affected Trees to be Cut along the IDRRIP

The Provincial Government of Isabela is on the process of requesting the DENR for an extension of the Special Tree Cutting Permit since it was not yet fully accomplished because the DENR advised the PGI to temporarily stop the operation as per instruction of former Sec. Gina Lopez last year. The Forestry Unit-Tree Marking Team continuously conducted inventory of affected trees to be cut to be submitted to the DENR in support to the request.

5. Social Development Support Activities to the Local Communities

The Provincial Government of Isabela is continuously implementing its Social Development activities in support to the Ilagan-Divilacan Road Rehabilitation and Improvement Project (IDRRIP) particularly the affected communities – the Agtas. The following were the activities undertaken as of reporting period, to wit:

The Regional Multi-sectoral Forest Protection Committee (RMFPC) chaired by Ms. Perla Visorro in coordination with PGI and the IDRRIP contractor (CM Pancho) conducted two (2) rounds of site visits and field monitoring activities of the road project on April 21, 2017 and October 26, 2017. The committee checked on the physical status of the road, its environmental compliance such as the reforestation area, nursery and other components of the project. After said visits, they gave their respective recommendations, suggestions and actions to be taken for further

INFORMATION, EDUCATION AND COMMUNICATION (IEC) ACTIVITIES

I. FOREST MANAGEMENT AND CONSERVATION DIVISION

Most of our IEC initiatives were all geared towards environmental awareness of our constituents in accordance with Section 2 of Executive Order No. 03, series of 2014 mandating the ISEP-TF to conduct massive IEC Campaigns particularly on environment and forest protection and proper solid waste management; and in response to Republic Act No. 9512 otherwise known as the National Environmental Awareness and education Act of 2008. This includes Aral Kalikasan sa Eskwela at Barangay — a behavioural change communication strategy that aims not only to increase level of awareness among its participants but also motivate them to act and do something about these prevailing environmental phenomena and such endeavours were also done in support to one of the major projects of the Provincial Government — the Ilagan-Divilacan Road Rehabilitation and Improvement Project (IDRRIP).

A. ARAL KALIKASAN SA MGA ESKWELA AT BARANGAY

For our Aral Kalikasan sa Eskwela at Barangay, we were able to reach out four (4) schools and five (5) barangays in the Municipality of Divilacan; two (2) schools in the Municipality of Maconacon; three (3) schools in the City of Ilagan and two (2) schools in the Municipality of Palanan composed of students, teachers, farmers, youth leaders, people's housekeepers, organization and barangay officials attended our advocacy campaigns for the protection and care of Mother Earth. The students, young as they are, are very much aware of what is happening with our surroundings and most of the barangay officials and residents as well began to realize the impacts of environmental degradation brought about by human activities and lack of concern to protect and conserve our forests.

III. MINERAL AND QUARRY RELATED IEC ACTIVITIES

A. Capability Building for Small-Scale Miners - October 26, 2017 - conducted together with MGB-R02 counterparts on October 26, 2017 at Barangays Anonang and Camarao, Cordon, Isabela participated by 110 stakeholders.



B. Consultative Meeting with Local Government Units and Contractors - Headed by the Hon. Governor Faustino G. Dy III, a meeting with Local Government Units thru their Local Chief Executive together with Contractors was conducted last November 29, 2017 to inform them on the current strategies of the Provincial Government in the strict implementation of Provincial Ordinance No. 5, series of 2014. Highlights of the said meeting include the instruction of the Honorable Governor for "No Tax Remittance, No Operations" policy and that legal action shall be applied to non-compliant haulers/permit holders/contractors. These initiatives are part of the mandate as provided by the Ordinance. They were further informed of the process that shall be undertaken prior to the payment of their billing which requires a clearance from the PTO that the contractors already remitted their sand and gravel taxes based on the sand and gravel requirement stated in the Program of Work. All conveyances used in sand and gravel operations are required to be accredited. All quarry taxes shall only be remitted to the Provincial Government of Isabela; remittances made to private haulers, permit holders and/or hardware shall require attachment of properly filled-up Delivery Receipts and/or Official Receipts. Proof of payments other than the two shall not be accepted.





INTERVENING AND OTHER RELATED ACTIVITIES

1. Pasa SRIP Watershed Management Restoration Project Inter-Agency Council/ Technical Working Group

As regular member of the IAC-TWG of the Pasa SRIP WMRP, ENRO personnel concerned continuously attended meetings and workshops of the Council and extended technical assistance in the preparation of the Watershed Management Restoration Plan for the 174 hectares identified area to be rehabilitated through reforestation of 100 hectares. agroforestry development of 30 hectares, enrichment planting of 19 hectares and riparian along the dam's rimbank with an estimated area of 25 hectares within the watershed area of

Pasa. As an update, the rehabilitation of the **174 hectares** is now on-going wherein seedlings were already procured and re-validation surveyof the areas was conducted to further improve the implementation of the project.

But prior to its final implementation, there was a revision of the original plan. Re-survey of the area was conducted so it was reduced from **174 hectares to 159.35 hectares** to be rehabilitated thru KOICA Fund.

2. Technical Working Group for the Nomination of Northern Sierra Madre Natural Park as Biosphere Reserve

The office together with partners from DENR and NGOs also initiated the crafting of Nomination Dossier of the Northern Sierra Madre Natural Park (NSMNP) as Biosphere Reserve under the PAMANA:UNESCO Man and Biosphere Program. The Technical Working Group attended Workshop/Write shop last September 26-27, 2017 at JAPI Hotel, Cauayan City which was organized by the Provincial Government thru ENR Office and aims to craft the draft for said dossier.

3. Technical Working Group for the Northern Sierra Madre Natural Park Management Plan

ENRO personnel concerned also regularly attended workshops and meetings regarding the creation of the updated NSMNP Management Plan.

4. Multi-partite Monitoring Team for SN Aboitiz NIA-MARIS Hydro-Electric Power Plant Project

Technical personnel from this office who is a regular MMT Member of the MSCHPPP attended regularly the quarterly meetings of the team to ensure that the proponent strictly follows the existing environmental laws to ensure lower health risks to the nearby communities. Said MMT conducted quarterly regular meetings.

5. Attendance during the Bamboo Benchmarking Mission spearheaded by the Department of Trade and Industry (DTI) Provincial Office

In support of the Provincial Bamboo Industry Development Council (PBIDC), the DTI Provincial Office has organized the Bamboo Benchmarking Mission composed of stakeholders from the bamboo industry in the province of Isabela. The participants comprise the value chain players from nurseries, plantations, trading, nodes, hubs, Provincial/City/Municipal LGUs and Government Agencies. This activity is in response to the RDC-EDC Resolution recognizing bamboo as one of the priority sectors in accordance to the 6-year old Executive Order No. 879 supporting bamboo development in the countryside. The purpose of the Mission was to benchmark from the experiences of the key players of the bamboo industry in the provinces of Laguna, Pampanga and Pangasinan as reference for the development and enhancement of the bamboo industry in the province of Isabela.

6. Donation of Forest Products

The Provincial Government is very much supportive of all the project undertakings of its constituents. During the year under report, it has granted several requests from various qualified beneficiaries for the donation of apprehended/confiscated forest products with a total of **2,096 pieces** of common hardwood species (CHW) lumber with an aggregate volume of **45,491.10 board feet** and **7 pieces** of narra flitches with a volume of **243.58 board feet**.



7. Monitoring and Provision of Technical Assistance and Seedlings to Recipients

Prior to seedling disposal, technical personnel are being dispatched to conduct assessment and evaluation of areas of the requesting parties to ascertain the actual seedling requirements and suitability of appropriate species needed. Then after which, the recipients are provided with technical assistance and proper guidance in their tree planning activities.
