FOREST MANAGEMENT AND CONSERVATION DIVISION

A. Forest Resources Development Activities:

1. Nursery Operations & Maintenance Activities

For the months under report, we have a seedling stock of 78.418 assorted fruit-bearing, forest trees bamboo and propagules. A total of 1,008 seedlings have been disposed to different requesting institution and individuals. Despite inevitable weather conditions, seedling mortality incurred was only minimal at 0.56% equivalent to **436** seedlings. The remaining stock balance as of March 31, 2019 at



the Provincial Nursery is **76,974.** Maintaining the nursery are three laborers contracted thru Job Order supervised by one (1) technical personnel.

To fully utilize the Provincial Clonal Nursery, technical personnel assigned at the Clonal Nursery initially established the hedge garden to be used as source of cuttings for cloning. Recognizing the need to equipped the personnel, this Office sent five (5) of its personnel to undergone Hands-on Training on Clonal Nursery Operation and Maintenance at the DENR-ERDB-WWRRDEC Clonal Nursery at Diadi, Nueva Vizcaya. On March 26 - 29, 2019, the trainees were briefed with the different components of a clonal nursery and exposed on actual cloning activities; from the preparation of soil media for rooting chambers, cutting of shoots, the processes prior to implanting and; the proper way of misting and maintenance of rooting beds during cloning process.

2. Climate Change & Mitigation/Adaptation & DRRM Measures thru Forest Landscape Restoration and Coastal Resource Management Program

a. Watershed Rehabilitation thru Reforestation

In response to the request of the Local Government of Palanan thru the Municipal ENR Office, this Office conducted site evaluation of the proposed Watershed Rehabilitation project area at Barangay Bisag together with MENRO staff. The area is located at the foothills of the mountain and was destructed by unknown kaingineros. Currently present in the area were scattered native banana trees only. The area is within the watershed irrigating the vast rice fields just below the foothills, hence are recommended for rehabilitation to ensure continuous water supply in the area.



b. Mangrove Forest Rehabilitation

In coordination with the Municipal Planning & Development Coordinator of the Local Government Unit of Maconacon, a 2-hectare mangrove area was identified for rehabilitation. Located at Barangay Reina Mercedes, the site was previously damaged by typhoons hence proposed under the Coastal Resources Management Program – Mangrove Rehabilitation Project. The project proposal was already approved and shall be implemented on April 2019 thru the contracted Job-Order workers.

c. Beach Forest Rehabilitation

As part of project monitoring, this Office visited the Beach Rehabilitation Project plantation at Sitio Sabang, Barangay Maligaya together with the Municipal ENR Officer and the contracted laborers. Established on October 2018, the 5month old plantation showed high rate of

survival evidenced by the sturdy seedlings. The laborers also conduct replanting according to the monitoring of MENRO where the seedlings planted were provided by their office. This is part of the LGU's commitment in ensuring the maintenance and protection of the project. Base on the result of project monitoring and evaluation, this Office recommended that the LGU be further assisted in the rehabilitation and protection of the said beach area and proposed for an additional 2-hectare rehabilitation area. As of March 2019, said proposal is now approved thru a Memorandum of Agreement between the Provincial Government of Isabela and the Local Government Unit of Palanan. Upon coordination with LGU Palanan thru the MENRO, implementation shall be done this April 2019.

3. Activities Undertaken in Support of IDRRIP

- a. Monitoring and Documentation
 - ✓ Updates on the road situations;
 - ✓ Ocular visit and field evaluation of the IDRRIP reforestation areas;
 - ✓ Documentation of the issues and concerns besetting the IDRRIP reforestation areas;
- b. Maintenance and Protection of the Reforestation Area
 - ✓ Maintenance of the reforestation sites thru Brushing, ring weeding, soil cultivation, mulching and application of organic fertilizer to the seedlings;
 - ✓ Collection and potting of new collected wildling; and
 - ✓ Constructed additional monitoring base camp at Sitio Disipon.
- c. Foot patrol works

B. Forest Protection and Law Enforcement:

1. Manning of Checkpoints

Among the six (6) checkpoints manned and maintained 24/7 by ISEP-TF Operatives, only the roving team and those assigned at Patrol Base Camp in Sitio Lagis concentrate on forest protection as the others were assigned to man different quarry outlets province-wide. The teams conducted surveillance, foot and mobile patrolling to detect occurrence of illegal gathering and transport of forest products. Aside from forest protection activities, those assigned at Sitio Lagis aside were at the same time conduct nursery activities, maintenance, protection and monitoring of the IDRRIP plantation areas.

2. Apprehension/Confiscation of Illegally Gathered/Transported Forest Products

For the months under report, there were no apprehension nor confiscation of illegally gathered and transported forest products, was recorded. However, the Provincial Government thru the ISEP-TF Operatives still conduct regular forest protection activities.

3. Donation of Forest Products

A total of **385** pieces equivalent to **6,222.34** board feet of common hardwood species were donated for used during the Bambanti Celebration, repair of the Provincial Day Care Facilities and as frames for the BRO livelihood programs of the Provincial Government. Also, this Office conducted inspection and documentation of the forest products donated to various schools.

ENVIRONMENTAL MANAGEMENT DIVISION

A. Search for the Most Environment Friendly Barangays

In preparation for the 2019 Search for the Most Environment-Friendly Barangays in the province, the provincial government thru the ENR Office conducted series of meetings with City/Municipal counterparts for the updates on the conduct of the Search.

On February 7, 2019, the Office spearheaded a meeting attended by the City/Municipal ENR Officers. The initial schedule of activities was presented together with the criteria to be used. It was reiterated that each city and municipality can only

recommend one (1) barangay as their main entry hence encourages all Local Government Units to conduct their own search as their way of monitoring RA 9003 implementation of all barangays. The criteria of the Search were presented on March 22, 2019 where certain criterions enhanced to specific standards of both the barangay and household involvement in the law implementation.

B. Updating of the Provincial 10 – Year Ecological Solid Waste Management Plan

In compliance to the provision of RA 9003 known as the Ecological Solid Waste Management Act of 2000, the Provincial 10-year ESWM Plan is regularly updated based on the submitted individual plans of its component cities and municipalities. With the aim to come-up with sustainable programs, projects and activities for the plan implementation, the Provincial Government thru the ENR Office assisted in the updating of individual plans thru technical and material extension for the conduct of Waste Analysis and Characterization Study (WACS) of requesting municipalities.

C. Vermi-composting Facility

Manned by two Job-Order workers and supervised by one (1) technical personnel, a total of **Four Thousand Sixty (4,060) Kilograms of vermicast organic fertilizer were produced** at the facility from January to March, 2019. Further, an Organic Garden was established and maintained utilizing the organic fertilizer produced while a total of **3,425 kilograms** were released to various requesting individuals and partner agencies specifically the Office of the Provincial Agriculturist maintaining the Provincial Vegetable Nursery.

D. <u>Ecosystem Management</u>

a. Clean-up Drives

In celebration of the World Water Day 2019, the Provincial Government thru this Office joined in the conduct of Region-wide River and Estero Clean-up activity last March 22, 2019 at Roxas, Isabela. Facilitated by the Local Government Unit of Roxas combined with personnel from the DENR and barangay officials, clean-up was made at Barangay San Rafael, along the waterways of a dried creek. Following the activity, this Office in partnership with the Municipal ENR Officer agreed for regular monitoring in the area to circumvent dumping of garbage and maintain cleanliness.

b. Pollution Control Measures thru Carbon Sink Plantation

The Office conducted monitoring of the established Carbon Sink Plantation project at Barangay Carmencita, Delfin Albano, Isabela last year of 2018. Survival rate was estimated to be at 90% hence recommended for the protection continuous and maintenance activities from the municipal counterpart and partner barangay.

As of March 31, 2019, this Office is currently coordinating with



the different municipal counterparts for the identification of their propose areas which shall be subjected for evaluation. Project proposals shall be prepared and submitted for areas suitable for the objective of the program.

E. Other Activities

a. Technical Assistance

The Mine Rehabilitation Fund (MRF) fee from extracted sand and gravel and other quarry resources is collected purposely for the rehabilitation of mined out/quarried area. Utilizing this fund thru an approved Environmental Work Program, this office supervised the tree planting project along Magat River within the jurisdiction of Barangays San Roque and Mapuroc, San Mateo and Barangay Rang-ay, Cabatuan, Isabela. With a total length of 12 kilometers riverbanks planted with bamboo and tree seedlings, the project activities were implemented by contracted Job-Order workers with the supervision and technical assistance of the ENR Office.



MINERAL RESOURCES MANAGEMENT DIVISION

A. <u>Processing and Issuance of Permits</u>

 a. Commercial Sand and Gravel (CSAG) – As of March 31, 2019, this office received Seventy One (71) CSAG Permit Applications from the different quarry locations within the province with corresponding administrative/processing fees collected by the Provincial Treasurer's Office amounting to Eight Hundred Four Thousand Three Hundred Thirty (Php 804,330.00) pesos only.

C. Site Verification and Inspection of Mining/Quarry Sites

a. Field Monitoring of Quarry Areas

To strictly implement Ordinance No. 5, Series of 2014 of the province, three (3) Environment and Natural Resources Office Personnel together with the thirty-seven (37) Isabela Environment Protection - Task Force (ISEP-TF) operative members were dispatched to conduct regular monitoring, field inspection and verification of sand and gravel extraction activities within the twenty seven (27) city and municipalities covering ninety one (91) barangays. Monitoring of sand and gravel extraction activities were conducted thru the use of reports, daily monitoring forms and delivery receipts regularly submitted to the Office by the checkers.

For the month of January 2019, **80,346.18 cu.m.** mineral and quarry resources were extracted representing **4,690.18 cu.m. Boulders**, **5,685.00 cu.m. G1/S1, 65,283.00**



cu.m. Mixed Gravel and 4,668.00 cu.m. Ordinary Earth with corresponding gross tax amounting to Two Million Nine Hundred Thirty Eight Thousand Seven Hundred Twenty Nine pesos and 90/100 (Php 2,938,729.90) only.

For the month of February 2019, **91,744.87 cu.m.** mineral and quarry resources were extracted representing **8,182.87 cu.m.** Boulders, **4,992.00 cu.m.** G1/S1, 68,414.00 cu.m. Mixed Gravel and 10,156.00 cu.m. Ordinary Earth with corresponding gross tax amounting to Three Million Three Hundred Seventy Three Thousand Eight Hundred Sixty Seven pesos and 85/100 (Php3,373,867.85) only.

For the month of March 2019, **76,225.58** cu.m. mineral and quarry resources were extracted representing **7,447.00** cu.m. Boulders, **6,613.00** cu.m. **G1/S1**, **50,959.52** cu.m. **Mixed Gravel and 11,206.00** cu.m. **Ordinary Earth** with corresponding gross tax amounting to **Two Million Eight Hundred Twenty Six Thousand Nine Hundred Thirty Three pesos and 20/100** (Php2,826,933.20) only.

In summary, a total of 248,316.63 cubic meter mineral and quarry resources were monitored to have been extracted from January 2, 2019 to March 31, 2019. This represents 20,320.05 cu.m. Boulders, 17,290.00 cu.m. G1/S1, 184,656.52 cu.m. Mixed Gravel and 26,030.00 cu.m. Ordinary Earth with corresponding gross tax amounting to Nine Million One Hundred Thirty Nine Thousand Five Hundred Thirty pesos and 95/100 (Php9,139,530.95) only.

b. Applied Area Verification and Inspection Activities

This Office conducted series of site verification and inspection activities to the applied area of Commercial Sand and Gravel (CSAG) Permit Applicants. Said activity aims to confirm the technical description based on the submitted survey plan and validate the suitability of these areas for sand and gravel extraction, including the environmental status based on ocular assessment.



A certain Mr. Eugenio Arcinas requested for technical assistance from this office in the conduct of ocular inspection at their proposed quarry area located at Ganano River, Barangay Apanay, Alicia, Isabela. The said area holds vast sand and gravel resources however, it is not suited for commercial purposes due to the quality of sand and gravel mixed with soil particles. In addition, quarry operation in the area was opposed by the management of Ganano Energy and Environment Electric Cooperative because of their proposed mini-hydro project in the area.

D. Provincial Mining Regulatory Board (PMRB) Meeting

The PMRB held its 1st Quarter Meeting last March 14, 2019 at the Provincial Ecology Center, Provincial Capitol, Alibagu, City of Ilagan, Isabela. Among the agenda was the review of applications for Commercial and Industrial Sand and Gravel Permit prior to the approval of the Provincial Governor. However, there was no quorum hence the Board was not able to indorse permit applications and agreed therefore that the Board shall meet for a special meeting solely for the endorsement of said applications.
