

Ms. Alejandro thought that maybe, Mr. Orasch was "scammed".</p> <p>&gt; Advised Mr. Orasch to seek / file complaint at a nearby Police station in their area regarding said "booking office".</p> <p>Ms. Alejandro said that the Section may assist them later in the booking of Mr. Orasch-bound for the Phils. Assured that the Migrants Section would be gladly help.</p> <p>&gt; Ms. Alejandro is the mother of Dr. Alejandro, COH of San Mariano Hospital. She first sought assistance from the OVP - Isabela Satellite office but was referred to the PGO. She thanked the PGO for the advice and assistance extended her.</p>
