COVID -19 Vaccination Launching and Roll-out for Pediatric 5-11 years old (February 14, 2022)

In the context of the prior issuance of Emergency Use Authorization (EUA) by Philippine Drug Administration (FDA) dated December 22, 2021, and based from the issuance from World Health the Organization (WHO), the DOH recommends the expansion of the COVID-19 vaccination program through the issuance of Department 2022-0041: Memorandum Interim Guidelines On The Management and Administration Of Tozinameran COVID-19 mRNA Pfizer COVID-19 Vaccine Pediatric to Population ages 5-11 years old.

A total of **7,480** or **3.45%** of the total eligible 5-11 years old pediatric population have received their 1st dose of Pfizer COVID-19 vaccine during the province wide roll-out. This remarkable event was actively participated mainly by RHUs/CHOs and hospitals, namely:
