"Republic Act No. 10152"Mandatory Infants and Children Health Immunization Act of 2011Signed by President Benigno Aquino III in July 26, 2010. The mandatory includes basic immunization for children under 5 including other types that will be determined by the Secretary of Health." This decree is directed for the common preventable diseases among children aged 9 to 59 months for Measles-Rubella as well as to check routine immunization status of children aged 12 to 23 months.

Disease eradication is a unique and highly demanding goal for the Immunization program for the reason that some of the local residents are still greatly influenced by certain cultural boundaries in their respective areas. As a result, health care providers must educate the public about the importance of subjecting their children for immunization to guarantee that there will be no missed children unimmunized throughout the province of Isabela.
