**PROVINCIAL PLANNING & DEVELOPMENT OFFICE**

The idea of establishing a local planning unit was envisioned during the administration of the late Ferdinand E. Marcos in 1975 to organize an RP-USAID Assistance Program for the purpose of construction, rehabilitating and improving rural infrastructures in selected provinces in the country. All provinces with this foreign grant program were required to create their own

Provincial Development Staff or commonly called PDS who will undergo rigid trainings on development planning, monitoring and evaluation system. In 1986, PDS was renamed to Provincial Planning & Development Office and mandated as the planning arm of the provincial government under the Local Government Code of 1991, which is a manifestation of its role in the development of the province.
