#### PNP-PDRRMC QUICK RESPONSE MOTORCYCLE RIDERS RENEWAL OF LTO DEPUTATION

To ensure unhampered enforcement of various Road Safety Laws such as the Governor's Executive Order No. 18, s. 2014. the Public Safety Office caused the renewal of Deputation licenses for our PNP-PDRRMC Quick Response Motorcycle Riders for the year 2018.

The new licenses were issued by the Region II Land Transportation Office on January 18, 2018, signed by the newly installed Regional Director, Romeo Solomon Sergio A. Sales and coursed through the Public Safety Office for distribution to the current batch of PNP riders who were initially tasked to operate within the province for the previous year while the selection process for new riders who will undergo LTO deputation training, First responder training, Highway Patrol Group


Motorcycle riding seminar and Law Enforcement Officer workshops are being coordinated with the Isabela Police Provincial Office to increase headcount and ensure a wider coverage of road safety operations across the Province.

With the current batch of riders, a total of 7,252 Road Safety Law violators were apprehended for the year 2017, 22% of which were driving without a helmet while 35% were driving without a valid license.
