## PTO IN ACTION

- **April 8, 2014 – Sangguniang Panlalawigan Session**

Provincial Treasurer Maria Theresa Araneta-Flores together with Ms. Maria Teresa P. Kanoy, Local Revenue Collection Officer III, attended and participated in the SP Session for the review and approval of the proposed Ordinance regulating the extraction, disposition, utilization and processing of quarry and other mineral resources within the territorial jurisdiction of the Province of Isabela and imposing various taxes and fees therefor.

- **April 10, 2014 – “Farmers’ Congress sa Barangay” at Barangay Catabban, Burgos, Isabela**

Provincial Treasurer Maria Theresa Araneta-Flores led the PTO Team in the recently concluded Farmers’ Congress sa Barangay held at the Gov. Faustino “Bojie” Dy Cultural and Civic Center, Barangay Catabban, Burgos, Isabela, which was inaugurated on same day, last April 10, 2014.

Checks representing Aid to Barangays in the amount of P100,000.00 per barangay, were released. Said checks were awarded to the 14 Barangay Captains of Burgos, Isabela by Hon. Governor Faustino G. Dy III together with the Hon. Congresswoman Ana Cristina S. Go and special guest, Hon. Daisy Reyes who came to grace the occasion. In addition, the PTO Team also handed to the Barangay Captains of Barangays San Miguel and Dalig the amount of P3,000.00 and P1,500.00 respectively, representing Financial Assistance for their barangay fiesta.

We were able to address various concerns from taxpayers on the computation and payment of real property taxes. The collection of Real Property Tax was referred to the Municipal Treasurer of Burgos who also joined the PTO Team, together with some of his staff. Some concerns of the Municipal Treasurer on Provincial Tax impositions and other treasury matters were addressed.

We likewise rendered technical assistance and reviewed for approval in the web system the Quarterly electronic Statement of Receipts and Expenditures (eSRE) reports of the Municipal Treasurer.

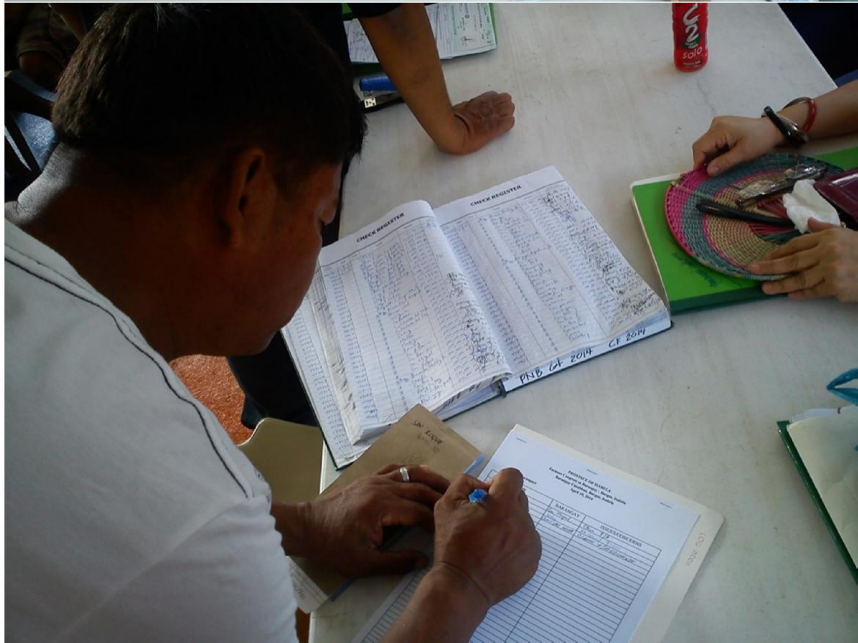
