Provincial Treasurer Maria Theresa Araneta-Flores led the PTO Group in the recently concluded “Farmers’ Congress sa Barangay” held at the Barangay Mambabanga, Luna, Isabela last April 22, 2014.

Checks in the total amount of P1,900,000.00 representing Aid to Barangays at P100,000.00 each were released. Said checks were awarded to the 19 Barangay Captains of Luna, Isabela by Hon. Governor Faustino G. Dy III together with the Hon. Vice Governor Antonio “Tonypet” Albano and Hon. Mayor Jaime Atayde. In addition, the PTO Team also handed Financial Assistance (cash) amounting to P1,000.00 to a resident of Barangay Harana, Luna, Isabela, based on an approved request.

We were able to address various concerns from taxpayers on the computation and payment of real property taxes and other taxes and fees involving transfer of properties. The payment of Real Property Tax was referred to the Municipal Treasurer of Luna who also joined the PTO Team. Some concerns of the Municipal Treasurer on Provincial Tax impositions and other treasury matters were also addressed.

Lastly, we also rendered technical assistance and reviewed for approval in the web system the Quarterly electronic Statement of Receipts and Expenditures (eSRE) reports of the Municipal Treasurer of Luna, Isabela.
