- **April 29, 2014 – Orientation on Seal of Good Local Governance (SGLG) conducted by the Department of Interior and Local Government held at Isabela Hotel, Cauayan City**

Provincial Treasurer Maria Theresa Araneta-Flores together with Ms. Maria Teresa P. Kanoy attended the Orientation on Seal of Good Local Governance (SGLG) conducted by the Department of Interior and Local Government-Isabela (DILG) headed by Provincial Director Elpidio A. Durwin, held last April 29, 2014 at Isabela Hotel, Cauayan City. Key functionaries of the Provincial Government of Isabela led by the Provincial Administrator, Atty. Noel Manuel R. Lopez together with representatives of the offices of the Provincial Accountant, Provincial Disaster Risk Reduction and Management Officer, Provincial Social Welfare Officer, Provincial Environment and Natural Resources Officer, Provincial Planning and Development Coordinator and the Philippine National Police Provincial Director participated said orientation on SGLG, which is a transition from the Seal of Good Housekeeping, to challenge local governments to continue good governance practices while providing better public services.

Checks in the total amount of P3,400,000.00 representing Aid to Barangays at P100,000.00 each were released and awarded by Hon. Governor Faustino G. Dy III together with Hon. Atty. Karen G. Abuan, SP Member 3rd District and Hon. Mayor Ian Paul Dy to the 34 Barangays of Alicia, Isabela during the program. In addition, Financial Assistance totaling to P42,000.00 were also released to some barangays of Alicia, Isabela.

We were able to address various concerns from taxpayers on the computation and payment of real property taxes and other taxes and fees involving transfer of properties. Fees and Charges due to the Provincial Government of Isabela were collected, while payments on Real Property Tax were referred to the Municipal Treasurer of Alicia who also joined the PTO Team. Some concerns of the Municipal Treasurer on treasury operations particularly on the issuance of Notice of Delinquencies to delinquent Real Property Owners were also addressed.

Lastly, we also rendered technical assistance and reviewed for approval in the web system the Quarterly electronic Statement of Receipts and Expenditures (eSRE) reports of the Municipal Treasurer of Alicia, Isabela.
