- **March 29, 2014 – Release of Students' Allowance BRO–Education Scholarship Program**

The PTO Team led by Cash Division Chief Ma. Luisa L. Galamgam released the allowances of the BRO-Education Program Scholars from the different municipalities and cities of the Province last March 29, 2014 at the Provincial Capitol.





- **April 2, 2014 – Release of Financial Assistance to 26 Barangays of Cabagan, Isabela**

The PTO representatives, Mr. Jojit Ochoa and Mr. Virgel Libunao released checks representing Financial Aid to 26 Barangays of Cabagan, Isabela totaling to P2.6M at P100,000.00 each barangay held on April 2, 2014 and clustered in 4 barangays: Casibarang Sur, Casibarang Norte, Centro and Luquilo.



- **April 2-3, 2014 – “Farmers’ Congress sa Barangay” at Maconacon and Divilacan, Isabela**

Provincial Treasurer Maria Theresa Araneta-Flores led the PTO Group in the recently concluded Farmers’ Congress sa Barangay held at Barangay Fely Hall, Maconacon, Isabela last April 2-3, 2014.

Checks representing Aid to Barangays in the amount of P150,000.00 per barangay, were released – a total of P 1,500,000.00 for the 10 Barangays of Maconacon and a total of P1,800,000.00 for the 12 Barangays of Divilacan . Said checks were awarded by Hon. Governor Faustino G. Dy III together with the Hon. Congressman Rodolfo T. Albano III, Hon. Silvestre Bello II, 1BAP Partylist representative, and SP Members Hon. Ric Justice E. Angobung and Hon. Rolando L. Tugade to the Barangay Captains and officials of the said municipalities. In addition, the PTO Team also handed to the Municipal Treasurer of Divilacan the amount of P5,000.00 representing Financial Assistance for their Municipal Festival.

We were able to address various concerns from taxpayers on the computation of real property tax, interests on unpaid tax, ten years back taxes of newly declared properties, transfer taxes including consolidation and subdivision fees. The payment of real property taxes were referred to the Office of the Municipal Treasurer of Maconacon, while payments on consolidation and subdivision fees, were attended to by the PTO Team. Payments were accepted and we issued the corresponding official receipts. Inquiries of some residents of Maconacon were also addressed particularly on the taxes and fees required to be paid in order that the properties they bought will be transferred and declared under their name.

The Barangay Captains and Treasurers were also briefed on the proper accomplishment of Official Receipts. Their accountability was emphasized on the Official Receipts in their custody.

Likewise, in coordination with the Provincial Cooperative and Development Office, loan repayment on BRO Livelihood of IGLO Divilacan was also accepted and we issued the corresponding Official Receipt to acknowledge the final payment of their loan.

The Municipal Treasurers and staff of LGU-Maconacon and Divilacan joined the PTO Team in order to address the needs of the residents of Maconacon and Divilacan, particularly on the issuance of Residence Certificate, which is one of the requirements needed in accomplishing the forms for the various BRO projects they wish to apply for.

We also took the chance to render technical assistance and reviewed for approval in the websystem the Quarterly electronic Statement of Receipts and Expenditures (eSRE) reports of the Municipal Treasurers of Divilacan and Maconacon. Considering that there is no internet access in the said municipalities, their reports will be uploaded in the eSRE Websystem by our office to the BLGF Regional Office for review before final approval by the BLGF Central Office. In addition, we also conducted a Revenue Performance Evaluation on their Treasury Operations to ensure their compliance on the submission of prescribed reports, remittances of trust and statutory obligations, particularly the province’s share on Real Property Tax, and to monitor their collection efficiency on all revenue categories.
