EXECUTIVE ORDER NO. 28-G-2019

CREATING THE EXECUTIVE-LEGISLATIVE AGENDA (ELA) TECHNICAL WORKING GROUP (TWG) OF THE PROVINCIAL LOCAL GOVERNMENT UNIT OF ISABELA

WHEREAS, it is the policy of the Provincial Government of Isabela (PGI) to ensure that all plans, programs, projects are the products of consultations and agreements with the Sangguniang Panlalawigan, stakeholders, and representatives of all sectors, and are the outcomes of diligent research, and all are in accordance with existing laws, ordinances, policies, and the PGI's Mission and Vision as embodied in its Citizen's Charter;

WHEREAS, pursuant to policy, the Governor issued Executive Order No. 16-B on 01 July 2013, "ORGANIZING THE EXECUTIVE-LEGISLATIVE AGENDA (ELA) TEAM OF THE PROVINCE OF ISABELA," to ensure that Executive development planning and the legislative priorities of the Sangguniang Panlalawigan are balanced, coordinated, harmonized, and established as the Executive-Legislative Agenda of the Provincial Local Government Unit of Isabela;

WHEREAS, there is a need to re-establish the ELA TEAM into a technical working group to craft the Executive-Legislative Agenda of the current Administration in the next three years, and which will strengthen the consultative and coordinative functions within the team, while ensuring a partnership that will result in policies that will positively impact on all aspects of life in the province of Isabela;

NOW THEREFORE, I, RODOLFO T. ALBANO III, by virtue of the powers vested in me by law as Governor of the Province of Isabela, hereby order the creation of the Executive-Legislative Agenda Technical Working Group or ELA TWG of the province of Isabela as follows:
