## EXECUTIVE ORDER NO. 59

CREATING THE PROVINCIAL PROJECT MANAGEMENT AND IMPLEMENTING UNIT (PPMIU) UNDER THE PHILIPPINE RURAL DEVELOPMENT PROJECT (PRDP)

WHEREAS, the Philippine Rural Development Project (PRDP) is a six-year national

government platform for an inclusive, value-chain oriented, and climate

resilient agriculture and fisheries sector;

WHEREAS, the Project will be jointly funded by the World Bank, National Government-

Department of Agriculture (DA) and the Local Government Units (LGUs);

WHEREAS, the Project's development objectives are to increase farmers' income and

develop a more market-oriented and climate-resilient agriculture and

fishery sector developed in program areas;


**WHEREAS,** the Project is now on its implementation stage and there is a need to create

the Provincial Project Management Implementation Unit (PPMIU) to better meet the requirements of the Program Design and to avail earlier

investment support.

**NOW THEREFORE, I, RODOLFO T. ALBANO III,** Governor of the Province of Isabela, by the powers vested in me by law, do hereby order the following:

Section 1. **Structure.** The Isabela Provincial Project Management Implementing unit (IPPMIU) shall have the following structure:

**Section 2. MANDATE.** The Grievance Redress Committee shall safeguard the people and the environment from any and all adverse effects of the implementation of PRDP projects, plans and activities and ensure the compliance of the same with existing relevant laws and ordinances;

Section 3. FUNDING. Funding for the operation of the Committee shall be sourced from the funds appropriated for PRDP activities.

Section 4. REPEALING CLAUSE. All Orders, circulars, memoranda, rules, regulations, and other issuances or parts thereof that are inconsistent herewith are hereby repealed, modified, or amended accordingly;

**Section 5. SEPARABILTY.** If any part or provision of the Executive Order is held invalid or unconstitutional, other provisions not affected thereof shall remain in full force and effect.

Section 6. EFFECTIVITY. This Executive Order shall take effect immediately.
