EXECUTIVE ORDER NO. 35 Series of 2022

REORGANIZING THE PROVINCIAL ECLIP COMMITTEE (ECC) IN COMPLIANCE TO THE PROVISION OF DEPARTMENT OF NATIONAL DEFENSE AND DILG JOINT MEMORANDUM CIRCULAR 2021-01

WHEREAS, the constitution declares that maintenance of peace and order, the protection of life, liberty, and property and the promotion of the general welfare are essential for the enjoyment by all the people with the blessings of democracy;

WHEREAS, the Local Government Code mandates Local Government Units(LGUs) to provide social welfare services which includes programs and projects for rebel returnees;

WHEREAS, a lasting peace calls for the pursuit of a comprehensive, integrated and holistic peace process to address the internal armed conflicts and the root causes involved, as well as, the implementation of programs to address the legal status and security of former rebels (FRs) and Former Violent Extremists (FVEs) and provision of community-based assistance to respond to their economic, social and psychological rehabilitation needs;

WHEREAS, the ECLIP Program through the ECLIP Committee (ECC) shall focus to facilitate the mainstreaming of FR and FVEs; enhance capacities of LGUs and National Government Agencies in the implementation and sustainability of the program; and compensate and remunerate all turned-in- firearms;

WHEREAS, the Provincial Peace and Order Council (PPOC) shall serve as the convergence mechanism to support the ECLIP Committee in the implementation of the program, it shall provide synchronized, focused and vigorous orchestrated government efforts on the integration of FR and FVEs in the province;

WHEREAS, there is a need to reconstitute the Committee to further enhance the participation of the Provincial Government to the all- inclusive peace process by institutionalizing the program pursuant to DILG –DND Joint Memorandum No. 2021-01 and pursuant further to the mandates of Executive Order no. 70 or “Institutionalizing the Whole-of-Nation Approach in Attaining Inclusive and Sustainable Peace, Creating a National Task Force to End Local Communist Armed Conflict (NTF-ELCAC), and Directing the Adoption of a National Peace Framework;

NOW THEREFORE, I, RODOLFO T. ALBANO III, Governor of the Province of Isabela, by virtue of the powers vested in me by law, do hereby decree the reorganization of the ECLIP Committee of the province of Isabela.

Section 2. NATURE AND CHARACTER. The E- CLIP Committee is an organizational unit that will implement the ECLIP program in the province and shall develop ECLIP committee Implementation Plan (ECCIP) which shall form part of the Peace and Order and Public Safety (POPS) Plan.

Section 3. COMPOSITION. The ECLIP Committee shall be constituted as follows:

Section 4. FUNCTIONS. The E- CLIP COMMITTEE shall have the following functions

1. Ensure the convergence effort in the immediate delivery of the identified services of the program including reproduction and dissemination of ECLIP Information, Education and Communication (IEC) materials;
2. Ensure proper documentation and referral of the needs of the FRs and FVEs to appropriate agencies and other partner institutions including profiling of FRs and FVEs;
3. Assist the FR and FVEs in completing the E- CLIP Enrollment Form. The FRs and FVEs should either sign or thumb mark the Form after completing it, attested by the DILG Provincial Director and approved by the Provincial Governor or by his/ her designated officer preferably the Provincial Administrator;
4. Assist the FR and FVEs in the preparation and implementation of his/her Former Rebel Reintegration Plan (FRRP)/Former Violent Extremist Reintegration Plan (FVERP) and Business Plan (*Mungkahing Proyekto*) through the PSWDO as the lead office. It shall have the option to come- up with its template (form) of FRRP/FVERP and Business Plan, provided the minimum datasets reflected in the attached form is complied;

5. Conduct regular ECLIP Committee meeting to discuss coordination and monitoring initiatives on ECLIP implementation, and resolve issues and concerns affecting the same, which shall form part of the report to PPOC during its meeting;
6. Facilitate the processing of FRs and FVEs birth certificates, identification (ID) cards/documents, registration to the Philippine Health Insurance Corporation (PHIC) and other necessary documents needed by the partner-stakeholders; and
7. Coordinate and report to the Department of Justice (DOJ), through Local/RPOCs and Local/Regional Task Forces to End Local Communist Armed Conflict (L/RTFs-ELCAC), the FRs and FVEs who will signify to avail the amnesty program, subject to existing laws and policies.

Section 5. FUNDING. Funding for the operations of the ECLIP Committee shall be sourced from the Office of the Governor.

Section 6. REPEALING CLAUSE. All issuances, orders, rules and regulations, or parts thereof that are inconsistent with any provision of this Order are hereby repealed or modified accordingly.

Section 7. EFFECTIVITY. This Executive Order shall take effect immediately.
