EXECUTIVE ORDER NO. 27 Series of 2023

AN EXECUTIVE ORDER CREATING THE PROVINCIAL HEALTH PROMOTION APPRAISAL TEAM (PHPAT) FOR THE PROVINCE-WIDE HEALTH SYSTEM OF THE PROVINCE OF ISABELA WHICH WILL FUNCTION AS THE OVERSIGHT BODY FOR THE 2023 HEALTHY PILIPINAS, HEALTHY ISABELA AWARDS

WHEREAS, Republic Act No. 11223, otherwise known as the Universal Healthcare (UHC) Act and its Implementing Rules and Regulations mandates an integrated and comprehensive approach in ensuring that all Filipinos are health literate, provided with healthy schooling, living, and working environments, and are protected from any hazards and risks that could adversely affect their health status;

WHEREAS, the Implementing Rules and Regulations of R.A. 11223 in Section 30 provides that Local Government Units shall issue and implement effective health promotion policies, programs, and activities that promote health literacy and healthy lifestyle among their constituents, prevent and control diseases and their risk factors to advance population health and individual wellbeing;

WHEREAS, Section 17 of the UHC Act further emphasizes the critical role of LGUs in health promotion, and requires that Province-wide and City-wide Health Systems shall have proactive and effective health promotion programs and campaigns as components of its population

WHEREAS, the Department of Health (DOH), in realizing the abovementioned provisions and as required by the UHC Act, formulated the DOH Administrative Order No. 2021-0063 or the Health Promotion Framework Strategy (HPFS) 2030 to serve as the overall national health promotion roadmap and basis for all health promotion policies, programs, and activities at the national, regional, and local levels;

WHEREAS, the HPFS 2030 requires that the development and implementation of health promotion policies, programs, and activities shall focus on the following priority areas and risk factors of: (i) diet and physical activity, (ii) environment health, (iii) immunization, (iv) substance use, including use of tobacco, alcohol, and illicit drugs, (v) mental health, (vi) sexual and reproductive health, and (vii) violence and injury prevention;

WHEREAS, the Province of Isabela through the Sangguniang Panlalawigan Resolution No. 2023-08-03, reaffirms its commitment to issue and implement effective health promotion policies, programs, and activities, adopt the provisions and principles of the DOH Administrative Order No. 2021-0063 or the Health Promotion Framework Strategy 2030. It shall also endeavor to work to progressively ensure dedicated local, committees, offices, units, and persons overseeing the implementation of health promotion policies, programs, and activities in the Province of Isabela as prescribed by the HPFS 2030;

WHEREAS, the DOH and the DILG shall serve as the recognition bodies for LGUs to be recognized as healthy communities, guided by the standards and indicators developed by the Healthy Communities Technical Working Group pursuant to the DOH-DILG Joint Administrative Order 2021-0002 on National Policy Framework on the Promotion and Recognition of Healthy Communities. Further guidance regarding the governance structure, capacity development, standards and indicators, monitoring and evaluation, and recognition of healthy communities shall be provided in a separate Manual of Procedures for the promotion and recognition of healthy communities;

WHEREAS, the Province of Isabela as the prime province in Cagayan Valley will conduct its first-ever 2023 Healthy Pilipinas, Healthy Isabela Awards to give recognition to local government units for the innovations on the implementation of the Seven Priority Areas of the Health Promotion Framework Strategy under the Department of Health Administrative Order No. 2021-0063.

NOW THEREFORE, I, RODOLFO T. ALBANO III, Governor of the Province of Isabela, by virtue of the power vested in me by law, do hereby order the following:

SECTION 1. CREATION AND MANDATE. The Provincial Health Promotion Appraisal Team (PHPAT) for the province-wide health systems which will function as the oversight body for the conduct of the 2023 Healthy Pilipinas, Healthy Isabela Awards is hereby created.

SECTION 2. COMPOSITION. The PHPAT- 2023 Healthy Pilipinas, Healthy Isabela Awards shall be composed of the following:

SECTION 3. FUNCTIONS AND RESPONSIBILITIES. The PHPAT-2023 Healthy Pilipinas, Healthy Isabela Awards shall perform the following:

- a. Formulate the guidelines and criteria as the basis of qualification and assessment of participating LGUs taking into consideration the HFPS 2030 priority areas and risk factors. If possible, reduced the set criteria into a Health Promotion Scorecard which will be used to validate and measure the LGUs performance as to relevance, innovativeness, adaptability, impact and scalability.
- b. Will oversee all preparations and implementations needed during the evaluation until the awards proper.

- c. Shall ensure timely dissemination of the approved guidelines of the activity.
- d. Shall organize or assign team members for the onsite validation
- e. Shall conduct on-site validation for the final evaluation of documents submitted by all participating LGUs.
- f. Shall convene the PHPAT- 2023 Healthy Pilipinas, Healthy Isabela Awards for the consolidation of scores based on document review and onsite validation.
- g. Shall determine additional parameters in case of a tie.
- h. Shall recommend to the Chairman of HPAT-Isabela the final results upon review of the analyzed tally scores. The Chairman of the PHPAT- 2023 Healthy Pilipinas, Healthy Isabela Awards shall review and approve the final results of assessment and evaluation.
- Report the outcome of the validation and final results to the Governor for his concurrence.

The Secretariat

- Shall perform all support functions and services pertinent to the over-all activities of the PHPAT- 2023 Healthy Pilipinas, Healthy Isabela Awards.
- b. Shall conduct initial review of the submitted Self-Appraisal Checklists from the participating LGUs and provide initial findings.
- c. Shall consolidate all the validated documents as per evaluation of the assigned team members and submit to Vice Chairman.
- d. Shall provide final report based on the consolidated scores of the participating LGUs.

SECTION 4. MEETINGS. The PHPAT- 2023 Healthy Pilipinas, Healthy Isabela Awards shall initially convene to discuss the implementing guidelines for the 2023 Healthy Pilipinas, Healthy Isabela Awards and its subsequent dissemination to C/MLGUs. Succeeding meetings will be conducted as recommended by the Chairman for the finalization of the identified awards recipient.

SECTION 5. FUNDING. To ensure efficient and effective operation, the budgetary requirement of the Health Promotion Appraisal Team shall be drawn from the provincial annual budgetary allocation of the IPHO and downloaded DOH-Grants.

SECTION 6. EFFECTIVITY. This Executive Order is effective immediately.
