## EXECUTIVE ORDER NO. 07 Series of 2024

## REORGANIZING THE PROVINCIAL COUNCIL AGAINST TRAFFICKING AND VIOLENCE AGAINTS WOMEN AND THEIR CHILDREN (PCAT-VAWC)

Whereas, the Philippines is a signatory to international human rights instruments such as the Universal Declaration of Human Rights, the Convention on the Elimination of all Forms of Discrimination Against Women, and the Convention of the Rights of the Child;

Whereas, in keeping with the fundamental freedoms guaranteed under the 1987 Constitution, it is the policy of the State to promote human dignity, protect the people from any threat of violence and exploitation, eliminate trafficking in persons, and mitigate pressures for involuntary migration and servitude of persons, as embodied in Republic Act 9208, otherwise known as the Anti-Trafficking in Persons Act of 2003, as amended by RA 10364 of the Expanded Anti-Trafficking in Persons Act of 2012;

Whereas, the State guarantees, by virtue of Republic Act 9262, otherwise known as the Anti-Violence Against Women and Their Children Act of 2004, full respect of human and individual rights, and recognizes the need to protect the family and its members particularly women and children, from violence and threats to their personal safety and security;

Whereas, it is a key policy of the Provincial Government of Isabela or PGI, to ensure, promote, and safeguard the safety of residents from all acts that violate their human and individual rights;

Whereas, the separation, transfer and/or promotion from office of the members of the PCAT-VAWC, have resulted in vacancies in the membership of the Council;

Now therefore, I, RODOLFO T. ALBANO III, Governor of Isabela, by virtue of the powers vested in me by law as governor of the Province of Isabela, hereby reconstitute the Provincial Council Against Trafficking and Violence Againts Women and their Children (PCAT-VAWC) of the province of Isabela, as follows:
