### EXPLANATORY NOTE

WHEREAS, this Honorable Body passed Ordinance No. 022, series of 2020, which authorized and approved the 2020 Annual Budget of the Provincial Government of Isabela (PGI);

WHEREAS, the PGI 2020 Annual Budget appropriated funds, in the amount of Two Million Pesos (Php2,000,000.00), for the Rehabilitation/Repair of Farm to Market Road, Rizal St., Brgy. 4 to Old Centro Proper, San Mateo, Isabela;

WHEREAS, on August 06, 2020, the Office of the Provincial Governor submitted a Letter addressed to this Honorable Body requesting that the amount of Two Million Pesos appropriated for the "Rehabilitation/Repair of Farm to Market Road, Rizal St., Brgy. 4 to Old Centro Proper, San Mateo, Isabela" be reprogrammed to the Account "Concreting of Old Centro 1 Farm-to-Market Road, San Mateo, Isabela", under the Economic Development Fund (EDF);

WHEREAS, the reprogramming of such amounts to the "Concreting of Old Centro 1 Farm-to-Market Road, San Mateo, Isabela" will help improve the transportation of farm goods and products to the market thus will improve their quality and salability to consumers which, ultimately, will promote the welfare of our farmers;

WHEREFORE, the passage of this Ordinance is earnestly sought.
