EXPLANATORY NOTE

WHEREAS, this Honorable Body passed Ordinance No. 022, series of 2020, which authorized and approved the 2020 Annual Budget of the Provincial Government of Isabela (PGI);

WHEREAS, the PGI 2020 Annual Budget appropriated funds, in the amount of One Hundred Seventeen Million (Php117,000,000.00), for the Payment of Loan Amortization;

WHEREAS, the country is experiencing an unprecedented health crisis due to the spread and pervasiveness of COVID-19;

WHEREAS, the ongoing pandemic has claimed thousands of casualties - and counting, caused the collapse of various economic industries, and the ruin of countless lives and livelihood. It also resulted in the rapid depletion of government funds and resources as the State struggles to contain and resolve the spread of COVID-19;

WHEREAS, this Honorable Body projects the next three calendar years of the Province, or until 2023, to be financially uncertain due to expected reduction of revenues and collections. Accordingly, it is incumbent upon the Provincial Government of Isabela to formulate effective local fiscal measures and sound monetary policies to ensure that the Province of Isabela will still achieve economic progress, growth, and

WHEREAS, on August 06, 2020, the Office of the Provincial Governor submitted a Letter addressed to this Honorable Body requesting that the amount of One Hundred Seventeen Million Pesos appropriated for the "Payment of Loan Amortization" be reprogrammed to different accounts for the implementation of various infrastructure projects as provided below;

WHEREAS, the amounts-to-be-reprogrammed aims, among other purposes, to provide Isabeleños with access to clean water system; create concrete measures to end recurring flooding incidents; generate employment; and to spur market activity and economic growth amidst this pandemic through the implementation of several infrastructure projects in various strategic places in the Province;

WHEREFORE, the passage of this Ordinance is earnestly sought.

NOW, THEREFORE, premises considered, and by virtue of the powers vested by law, this Honorable Body has resolved to enact –
