A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T. ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA (PGI) A CONTRACT OF LEASE WITH RINA S. REYES FOR THE RENTAL OF A CERTAIN PROPERTY IN QUEZON CITY, MANILA WHICH HOUSES THE PGI METRO MANILA MIGRANT HELP DESK

WHEREAS, the PGI has also established a Migrant Help Desk in Metro Manila to ensure that Isabeleño OFWs and their families, and those Isabeleños who are in Metro Manila to process their overseas employment, have ready and certain access to assistance from the Provincial Government;

WHEREAS, the PGI executed a Contract of Lease with Mr. Robert R. Silang to lease a certain property owned by Mr. Robert Silang situated in 16 Kayumanggi Street, West Triangle Homes, Quezon City which the PGI utilizes to house its Metro Manila Migrant Help Desk. Such property is now owned by Rina S. Reyes;

WHEREAS, such Contract of Lease has lapsed, and the PGI is desirous to renew such agreement to ensure that the PGI's extension of assistance to Isabeleños in Metro Manila remains unhampered;

WHEREAS, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREFORE, premises considered, upon motion of the Honorable Alfredo V. Alili, duly seconded and approved by all the members present in a session duly assembled, it was –
