WHEREAS, the Philippines is experiencing an unprecedented health crisis due to the spread and pervasiveness of COVID-19;

WHEREAS, the Provincial Government of Isabela (PGI) fully and strictly adheres to the guidelines, protocols, and regulations of the National Government relative to the containment and resolution of the COVID-19 crisis:

WHEREAS, the National Government, with the assistance of local government units including the PGI, implemented the Hatid Probinsya Program with the aim of resolving the transportation needs of Locally Stranded Individuals (LSIs) who desire to return home in the Province amid this health crisis;

WHEREAS, pursuant to national health and safety protocols, Isabeleño LSIs are required to undergo 14-day quarantine to ensure that they are negative from COVID-19 before they can be allowed to return to their homes;

WHEREAS, the influx of Isabeleño LSIs resulted in the full occupancy of local quarantine facilities. As such, there is an urgent and clear necessity to establish additional quarantine facilities to house the incoming horde of Isabeleño LSIs;

WHEREAS, the PGI and Water World Grand Resort Inc., owned by Ms. Edna U. Utrillo, seeks to forge a partnership thru a Lease Agreement, for the utilization of the latter's premises as a quarantine facility for COVID-19 cases;

WHEREAS, Section 465, par. VI of the Local Government Code empowers the Provincial Governor to represent the Province in all its business transactions and sign in its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREAS, this Honorable Body confers upon the Provincial Governor, Honorable Rodolfo T. Albano III, the requisite authority to sign in behalf of the PGI a Contract of Lease with Ms. Edna U. Utrillo for the utilization of Water World Grand Resort Inc. as a quarantine facility for Isabeleño LSIs;

WHEREFORE, premises considered, upon motion of Hon. Marco Paolo A. Meris, duly approved and seconded in a session duly assembled it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T.
