ALBANO III, TO UTILIZE THE SUM OF ONE HUNDRED FIFTY MILLION ONE HUNDRED FIFTEEN THOUSAND SEVEN HUNDRED FIFTY-TWO PESOS (Php150,115,752.00) FROM THE UNUTILIZED TOBACCO EXCISE TAX SHARES OF THE PROVINCIAL GOVERNMENT OF ISABELA FOR THE YEARS 1997 TO 2007, 2012, 2013, 2011 AND 2014, AND 2015 FOR THE PROCUREMENT OF HAULING OR DUMP TRUCKS

WHEREAS, it is the policy of the Provincial Government of Isabela to promote and prioritize the welfare of its local farmers, and further recognizes the significance of having a strong and thriving agricultural industry in order to realize its goal of attaining sustainable and lasting food security in the Province;

WHEREAS, on June 19, 2020, the Office of the Vice Governor received a Letter from the Office of the Provincial Governor requesting for the grant of authority for the purchase of hauling or dump trucks, in the amount of One Hundred Sixty Million Pesos (Php160,000,000.00), making use of the unutilized tobacco excise tax shares of the Provincial Government of Isabela for the previous years, except year 2016;

WHEREAS, the Committee on Finance and Appropriations, in consultation with the Provincial Accountant's Office and the Provincial Treasurer's Office, determined that the Provincial Government of Isabela has a fund balance of One Hundred Fifty Million One Hundred Fifteen Thousand Seven Hundred Fifty-Two Pesos (Php150,115,752.00) from its Tobacco Excise Tax Shares for the years 1997 to 2007, 2012, 2013, 2011 and 2014, and 2015;

WHEREAS, this Honorable Body deems it appropriate and necessary to make use of the unutilized tobacco excise tax shares of the Provincial Government of Isabela for the years provided in the previous clause for the purchase of hauling and dump trucks which will help facilitate the production, harvest, and transport of the yields and produce of our local tobacco farmers thus providing them with much-needed support and assistance, especially during these challenging times, in furtherance of the goal of the Province of attaining sustainable and lasting food security;

WHEREFORE, premises considered, upon motion of Hon. Faustino U. Dy IV, duly approved and seconded in a session duly assembled it was –

RESOLVED, AS IT HEREBY RESOLVES, TO ADOPT A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HONORABLE RODOLFO T.
