AN ORDINANCE AMENDING SECTION 3 OF ORDINANCE NO. 2020-05-01 OR OTHERWISE KNOWN AS THE COMMANAGEMENT ORDINANCE OF THE PROVINCE OF ISABELA

Be it Ordained by the Sangguniang Panlalawigan of the Province of Isabela, in a session duly assembled, THAT:

SECTION 1. Section 3 of Ordinance No. 2020-05-01 is hereby amended and now to read as follows:

SECTION 3. COMPOSITION AND RESPONSIBILITIES OF THE CRISIS MANAGEMENT COUNCIL-

CHAIRMAN: Provincial Governor VICE CHAIRMAN: Vice Governor

ACTION OFFICER: Provincial Administrator

MEMBERS:

- Police and Military Personnel
- Sangguniang Panlalawigan Members
- Provincial Department Heads
- Municipal/City Local Chief Executives
- Other Agencies as may be deemed necessary by the Council

The following Members shall be designated as the Crisis Management Officers who shall assume authority, effectively carry out functions, and take on responsibilities and accountabilities for each form of threat.

- 1.) SP Member Chairman of the Committee on Public Order and Safety / Head of Public Order and Safety Unit (POSU) / the Provincial Director of the PNP.
- Primarily responsible for all threats to peace and order, e.g., civil disturbances, terrorism, etc.

2.) The Chairman of the PDRRMC/PSWDO/ BFP Chief/Provincial Engineer

- Primarily responsible for all threats of natural calamities such as typhoons, floods, earthquakes, conflagrations, and all forms of human-induced catastrophes, and emergency responses related thereto;

3.) The Provincial Health Officer/PSWDO

- Primarily responsible for all forms of emerging and current threats to public health which include disease outbreaks, epidemics, and pandemics;
- 4.) Provincial Planning and Development Officer/Provincial Treasurer/Provincial Accountant/ Provincial Internal Audit and Control Officer/Provincial General Services Officer/Provincial Budget Officer/ SP Member Chairman of the Committee on Finance and Appropriations, Committee of Ways and Means, Committee on Market and Slaughterhouse/DTI Officer
- Primarily responsible for budget allocation or facilitation of financial aids to disaster-related needs, and other threats to consumer welfare.

SECTION 2. REPEALING CLAUSE. – All orders, memoranda, rules and regulations, or any part of parts hereof, inconsistent with the provisions of this ordinance are hereby revoked or modified accordingly.

SECTION 3. SEPARABILITY CLAUSE. – If for any reason a provision of this Ordinance is declared invalid or unconstitutional, all other provisions hereof not affected thereby shall continue to be in full force and effect.

SECTION 4. EFFECTIVITY CLAUSE. – This ordinance shall take effect upon its approval.
