WHEREAS, as a partner of the PRDP in its I-BUILD Project, the Provincial Government of Isabela (PGI) proposed for the Construction of an NMI Agri Coop Warehouse for the Nagkaisang Magsasaka ng Isabela (NMI) Agricultural Cooperative to be funded under the DA-PRDP;

WHEREAS, as a condition for the approval of the Project, NMI must donate the project site to the PGI in accordance with Department Administrative Order No. 38;

WHEREAS, to comply with the aforesaid condition, the Nagkaisang Magsasaka ng Isabela Agriculture Cooperative has agreed to donate to the PGI two (2) parcels of land with improvements, which are registered under its name, situated in Barangay Nungnungan I, Cauayan City, Isabela, containing an aggregate area of One Thousand Five Hundred (1,500) square meters, more or less;

WHEREAS, said properties are covered under Transfer Certificate of Title No. 035-2021001975B and Transfer Certificate of Title No. 035-2021001976B, containing an area of Eight Hundred Twenty Four (824) square meters and Six Hundred Seventy Six (676) square meters, respectively, or an aggregate area of One Thousand Five Hundred (1,500) square meters, more or less;

WHEREAS, under Section 465, (b) (1) (vi) of R. A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the aforesaid Deed of Donation on behalf of the Provincial Government of Isabela;

WHEREAS, premises considered, upon motion of Honorable Adrian Philip S. Baysac, duly approved and seconded in a session duly assembled, it was -
