WHEREAS, the Provincial Government of Isabela (PGI) aims to promote modern agricultural techniques and technologies in the cultivation to the harvest of agricultural produce, including fruit bearing trees and facility-grown vegetables;

WHEREAS, thru the Seasonal Agricultural Sector Development Exchange Program, qualified agricultural trainees from the Province of Isabela will be trained and accommodated by the local government of Jinan County, South Korea;

WHEREAS, the training in Jinan County, South Korea by qualified Isabela farmer-trainees with modern agricultural techniques, technologies and innovations will help improve the production, creativity, and business planning within the Province of Isabela;

WHEREAS, to avail the Seasonal Agricultural Sector Development Exchange Program and its implementation thereof, it requires the execution of a Memorandum of Agreement between the PGI and Jinan County, South Korea;

WHEREAS, under Section 465, (b) (vi) of R. A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

**WHEREAS,** premises considered, upon motion of Honorable Adrian Philip S. Baysac, duly approved and seconded in a session duly assembled, it was –
