A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 2022-1256 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF SAN MARIANO, ISABELA AS INTRA VIRES

WHEREAS, pursuant to Article 468(a)(i) of the Local Government Code, the Sangguniang Panlalawigan has the authority to "review all ordinances approved by the sangguniang of component cities and municipalities" and to "determine whether these are within the scope of the prescribed powers of the sanggunian";

WHEREAS, presented before this Honorable Body is Municipal Ordinance No. 2022-1256 of the Municipal Local Government Unit of San Mariano, Isabela (MLGU San Mariano) titled "An Ordinance Authorizing the Proposed Borrowing of the Municipality of San Mariano, Province of Isabela, in the Amount of Five Hundred Forty Million Pesos (Php540,000,000.00) to Fund the Construction of Level III Water System, Concreting of Farm-to-Market Roads, and Construction of Two-Storey Multi-Purpose Building in 35 Barangays of this Municipality";

A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 2022-1256 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF SAN MARIANO, ISABELA AS INTRA VIRES

WHEREAS, as stated in the Ordinance, MLGU San Mariano will enter into a Loan Agreement with the Land Bank of the Philippines for the amount of Five Hundred Forty Million Pesos (Php540,000,000.00) which shall be utilized to finance the implementation of various infrastructure projects in San Mariano, Isabela;

WHEREAS, Section 297(a) of the Local Government Code allows local government units to contract loans, credits, and other forms of indebtedness with any government or domestic private bank and other lending institutions to finance the construction, installation, improvement, expansion, operation, or maintenance of public facilities, infrastructure facilities and the implementation of other capital investment projects, subject to such terms and conditions as may be agreed upon by the local government unit and the lender;

WHEREAS, this Honorable Body recognizes that local government units possess direct information concerning the needs of their citizens and the conditions within their jurisdiction and thus have the appropriate standing and capacity to identify the programs, projects, and activities that will further the welfare of their people;

WHEREAS, after careful review and with due consideration to the recommendation of the Provincial Budget Office interposing no objection and stating no adverse finding to MLGU San Mariano Ordinance No. 2022-1256, this Honorable Body find that the said ordinance is a valid exercise of the legislative powers of their sanggunian and within the authority of MLGU San Mariano as prescribed by law subject to compliance with the budgetary limitations for debt servicing as provided in Section 324 of the Local Government Code;

WHEREFORE, upon motion of Honorable Delfinito Emmanuel L. Albano, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 2022-1256 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF SAN MARIANO, ISABELA AS INTRA VIRES
