WHEREAS, to acquire a proactive and effective health promotion program or campaign, every Local Government Units (LGUs) are guided by the Health Promotion Framework Strategy to issue and implement effective health policies that promotes health literacy and healthy lifestyle among their constituents, prevent and control diseases and their risk factors, to advance population health and individual wellbeing;

WHEREAS, by virtue of DOH Department Order No. 2022-0037, the Provincial Government of Isabela (PGI) has been allocated a fund of Four Million Four Hundred Fifty Two Thousand Pesos (Php 4,452,000.00) for the implementation of the Health Promotion Playbook;

WHEREAS, to assist the PGI in accomplishing the requirements of the Universal Health Care Act, the DOH Health Promotion Bureau together with Centers for Health Development, will develop and implement the Health Promotion Playbook and a package of evidence-based interventions with ready-to-use tools, materials, and guides to be adopted and implemented by the PGI in its health promotion programs;

WHEREAS, PGI's implementation of the Health Promotion Playbook requires the execution of a Memorandum of Agreement between the PGI and the Department of Health Cagayan Valley Center for Health Development;

WHEREAS, under Section 465, (b) (vi) of R. A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREAS, premises considered, upon motion of Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT IS HEREBY RESOLVED, TO PASS A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR, RODOLFO T.
