ALBANO III, TO SIGN IN BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA, A MEMORANDUM OF AGREEMENT WITH THE NATIONAL FOOD AUTHORITY (NFA) FOR THE IMPLEMENTATION OF PALAY MARKETING ASSISTANCE PROGRAM FOR LEGISLATORS AND LOCAL GOVERNMENT UNITS (PALLGU)

WHEREAS, the PGI recognizes the need to provide assistance to local farmers in marketing their produce by linking them to local government, legislators and other government agencies which can provide price premium support on top of the regular government support price;

WHEREAS, the National Food Authority established the Palay Marketing Assistance Program for Legislators and Local Government Units (PALLGU) which provides opportunities to play farmers to maximize their income;

WHEREAS, to realize such program, the NFA and the PGI agreed to enter into a Memorandum of Agreement which will benefit the farmers and the province as a whole;

WHEREAS, Section 465 (b) (1) (vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign contracts and such other documents relative to the execution of his functions, upon the authority vested upon him by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

**WHEREAS**, premises considered, upon motion of Honorable Philip Adrian S. Baysac, duly approved and seconded in a session duly assembled, it was -
