WHEREAS, ER 1-94 was promulgated Department of Energy to operationalize the implementation of giving direct benefits to the province, city, or municipality that Hosts the energy resources and energy generating facilities;

WHEREAS, the Isabela Biomass Energy Corporation is an energy generation corporation operating in the Province of Isabela. As such, the Provincial Government of Isabela is entitled to financial benefits as promulgated by ER 1-94;

WHEREAS, based on records submitted to this Honorable Body, the Provincial Government of Isabela, as of January 2022, has an accrued financial benefit from its ER 1-94 share in the energy generation operations of Isabela Biomass Energy Corporation amounting to Php1,291,641.06 which is yet to be programmed. Such amount is broken down as follows:

WHEREAS, the Department of Energy issued Department Circular No. 2020-04-0008 providing the rules and guidelines for the effective administration, management, utilization, and implementation of ER 1-94 funds to contain, mitigate, and eliminate the transmission of COVID-19 and mitigate the effects thereof to the communities and individuals of Host LGUs during the effectivity of the State of Public Health Emergency;

WHEREAS, Proclamation No. 1218, s. 2021 extended the period of the State of Calamity throughout the Philippines, as declared in Proclamation No. 1021, s. 2020, from September 13, 2021 to September 12, 2022, unless earlier lifted or revoked as circumstances may warrant;

WHEREAS, as of this date, there is no proclamation lifting or revoking the declaration of State of Calamity throughout the country as provided in Proclamation No. 1218, s. 2021;

WHEREAS, similar to other territories, the Province of Isabela suffered immensely from the spread of COVID-19. While social conditions have considerably improved over the past months, the Province of Isabela is yet to fully recover from the economic distress caused by the pandemic;

WHEREAS, presented for the consideration of this Honorable Body is the proposed Annual Work Program of the Provincial Government of Isabela for the year 2022 which seeks to utilize its share from the energy generation operations of Isabela Biomass Energy Corporation, as promulgated by ER 1-94, to fund programs for the management of the effects of COVID-19;

WHEREAS, after careful perusal, this Honorable Body determined that the projects outlined in the proposed Annual Work Program are among those identified to be eligible for funding as provided under DOE Department Circular No. 2020-04-0008, just, lawful, and beneficial to the people of the Province of Isabela;
