A RESOLUTION UPHOLDING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 2022-007 OF THE MUNICIPALITY OF ALICIA, ISABELA, ENTITLED, "AN ORDINANCE RECLASSIFYING FROM AGRICULTURAL LAND TO OTHER USES LAND THE PARCELS OF LANDS BEARING TRANSFER CERTIFIACTE OF TITLE NOS. T-175434, T-175432, T-175430, T-175433, T-175431, AND TCT-035-2018004266 CONTAINING A TOTAL AREA OF 132,426 SQ.M. LOCATED AT BARANGAY M.H. DEL PILAR, AICIA, ISABELA"

WHEREAS, Section 20 (a) of R. A. 7160 or the Local Government Code of 1991 grants a municipality the power to authorize the reclassification of agricultural lands into a residential, commercial or industrial purposes and was more specifically stated as follows:

"A city or municipality may, through an ordinance passed by the sanggunian after conducting public hearings for the purpose, authorize the reclassification of agricultural lands and provide for the manner of their utilization or disposition in the following cases:

(1) when the land ceases to be economically feasible and sound for agricultural purposes as determined by the Department of Agriculture or (2) where the land shall have substantially greater economic value for residential, commercial, or industrial purposes, as determined by the sanggunian concerned."

WHEREAS, Municipal Ordinance No. 2022-007 was enacted by the Sangguniang Bayan of Alicia, Isabela, reclassifying a lot covered by Transfer Certificate of Title nos. T-175434, T-175432, T-175430, T-175433, T-175431 situated at Barangay M.H. Del Pilar, Alicia, Isabela with a total lot area of 132,426 square meters, more or less on February 09, 2022;

**WHEREAS,** Section 3 of the Memorandum Circular No. 54, Series of 1993, of the Office of the President provides that, "All ordinances authorizing the reclassification of agricultural lands shall be subject to the review and approval by the province in the case of component city or municipality";

WHEREAS, having been authorized to review ordinances reclassifying agricultural lands under the abovesaid Memorandum Circular, the Committee on Housing, Subdivision and Land Use Classification conducted a thorough review of Ordinance No. 2022-007 of the Municipality of Alicia, Isabela and finds the same to be in consonance to the mandate of the Sangguniang Bayan pursuant to Section 20 of R.A. No. 7160. Thus, said ordinance is within the purview of the powers conferred by law to their Sangguniang Bayan;

WHEREAS, the Committee recommended to the Body to uphold the validity of Ordinance No. 2022-007 of the Municipality of Alicia, Isabela;

WHEREAS, premises considered, upon motion of HON. ED CHRISTIAN S. GO, duly approved and seconded in a session duly assembled, it was —
