A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 2021-045 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF GAMU, ISABELA AS INTRA VIRES

WHEREAS, pursuant to Article 468(a)(i) of the Local Government Code, the Sangguniang Panlalawigan has the authority to "review all ordinances approved by the sangguniang of component cities and municipalities" and to "determine whether these are within the scope of the prescribed powers of the sanggunian";

WHEREAS, presented before this Honorable Body for its review is Municipal Ordinance No. 2021-045 of the Municipal Local Government Unit of Gamu, Isabela (MLGU Gamu) titled "Approving the Proposed Borrowing of the Municipal Government of Gamu, Isabela in the Amount of Twenty Million Pesos (Php20,000,000.00) with the Land Bank of the Philippines to Finance the Implementation of the Project – Installation of Solar Streetlights in the Municipality of Gamu, Isabela subject to Pertinent Laws, Terms and Agreements";

WHEREAS, as stated in the Ordinance, MLGU Gamu will enter into a Loan Agreement with the Land Bank of the Philippines for the amount of Twenty Million Pesos (Php20,000,000.00) which shall be utilized to finance the implementation of the Installation of Solar Streetlights project in Gamu, Isabela;

A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 2021-045 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF GAMU, ISABELA AS INTRA VIRES

WHEREAS, Section 297(a) of the Local Government Code allows local government units to contract loans, credits, and other forms of indebtedness with any government or domestic private bank and other lending institutions to finance the construction, installation, improvement, expansion, operation, or maintenance of public facilities, infrastructure facilities and the implementation of other capital investment projects, subject to such terms and conditions as may be agreed upon by the local government unit and the lender;

WHEREAS, this Honorable Body recognizes that local government units possess direct information concerning the needs of their citizens and the conditions within their jurisdiction and thus have the appropriate standing and capacity to identify the programs, projects, and activities that will further the best interest and welfare of their people;

WHEREAS, after careful review and with due consideration to the recommendation of the Provincial Budget Office interposing no objection and stating no adverse finding to MLGU Gamu Municipal Ordinance No. 2021-045, this Honorable Body find that the said ordinance is a valid exercise of the legislative powers of their sanggunian and within the authority of MLGU Gamu as prescribed by law subject to compliance with the budgetary limitations for debt servicing as provided in Section 324 of the Local Government Code;

WHEREFORE, upon motion of Honorable Delfinito Emmanuel L. Albano, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION DECLARING MUNICIPAL ORDINANCE NO. 2021-045 OF THE MUNICIPAL LOCAL GOVERNMENT UNIT OF GAMU, ISABELA AS INTRA VIRES
