WHEREAS, currently, the Governor Faustino N. Dy, Sr. Memorial Hospital in Ilagan City, Isabela has an authorized bed capacity of One Hundred (100). However, due to the COVID-19 pandemic experience of our Province, we have discovered that the available 100 bed capacity in public hospitals is insufficient to the demands of the public;

WHEREAS, consistent with the hospital development plan of the GFNDy Sr. Memorial Hospital, the Provincial Government of Isabela (PGI) intends to expand and upgrade the existing professional health care services and facilities of the hospital thru the proposal of the increased number of hospital beds;

WHEREAS, the expansion of GFNDy would give aid in ameliorating efficient healthcare services within the Province to sustain the growing demands of patients;

WHEREAS, this Body deems it beneficial and advantageous for the Province to express support in augmenting the number of bed capacity of the Governor Faustino N. Dy, Sr. Memorial Hospital in Ilagan City, Isabela from One Hundred (100) to Five Hundred (500) bed capacity, and appropriating funds therefor;

WHEREAS, premises considered, upon motion of Honorable Emmanuel Joselito B. Añes duly approved and seconded in a session duly assembled, it was -

RESOLVED, AS IT IS HEREBY RESOLVED, TO PASS A RESOLUTION EXPRESSING SUPPORT FOR THE AUGMENTATION OF THE NUMBER OF BED CAPACITY OF THE GOVERNOR FAUSTINO N. DY, SR.
