the Isabela Animal Disease Diagnostic Laboratory plays a critical role in identifying and managing animal diseases that can impact livestock and the agricultural economy of the province, as well as public health, making it imperative to strengthen its diagnostic capabilities.

the Provincial Government of Isabela has allocated funds for various programs under Other Programs/Projects and Activities - Capital Outlay (Current) for Fiscal Year 2024, totaling ₱2,658,000.00, namely: Rabies Control Program, Swine Development Program, Station **Development Program.**

while these programs remain valuable, the urgent need to equip and enhance the diagnostic facilities of the Isabela Animal Disease Diagnostic Laboratory necessitates the reprogramming of these funds.

the reprogramming of these funds is essential to procure the necessary laboratory machines and diagnostic equipment to improve the speed and accuracy of disease detection, thus enhancing the province's capacity to control and prevent the spread of animal diseases.

investing in the diagnostic laboratory will enable the Provincial Government of Isabela to better respond to emerging health threats, protect local livestock, and safeguard the livelihoods of farmers, contributing to the long-term economic stability of the province.

the reprogramming of these funds from less urgent programs will allow for a more immediate and effective response to the needs of the Isabela Animal Disease Diagnostic Laboratory, thereby strengthening its capacity to serve the people of Isabela.

In view of the foregoing, the approval of this Ordinance is earnestly sought.

Section 1. Coverage. This Ordinance shall cover the items, accounts, and appropriations provided in Section 2 hereof.

Section 3. Utilization of Funds. The disbursement and utilization of funds to be made pursuant to this Ordinance shall adhere to existing government budgeting, accounting, and auditing laws, rules, and regulations.

Section 4. Authority to Reprogram. To ensure that the resources and development plans of the Provincial Government of Isabela are responsive to the current development issues and that its programs, plans, and activities are effectively implemented, the Governor is hereby empowered to augment or reprogram any savings that may be derived from the herein reprogrammed funds to any item within the same appropriation.

Section 5. Effectivity. This Ordinance shall take effect immediately upon its approval.
