**AN ORDINANCE APPROVING AND ADOPTING THE PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL RESOLUTION NO. 02-2025, THEREBY APPROVING FOR THIS PURPOSE THE REPROGRAMMING OF UNEXPENDED FUNDS FROM THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND (LDRRMF) OF THE PROVINCIAL GOVERNMENT OF ISABELA FROM FISCAL YEARS 2021 TO 2024 AMOUNTING TO FOUR HUNDRED EIGHTY-SIX MILLION NINE HUNDRED THIRTY-SIX THOUSAND SIX HUNDRED SEVENTY-SIX PESOS AND 69/100 (₱486,936,676.69) TO AUGMENT THE 2025 LDRRMF INVESTMENT PLAN**

**EXPLANATORY NOTE**

The Provincial Government of Isabela is committed to safeguarding the rights of every Isabeleño to life, safety, and security by advancing disaster preparedness and resilience efforts through evidence-based and needs-responsive programs. This commitment is anchored in the principles of Republic Act No. 10121, also known as the *Philippine Disaster Risk Reduction and Management Act of 2010*.

As a province frequently affected by typhoons, flooding, and other calamities, Isabela maintains a strong focus on ensuring the efficient use of its Local Disaster Risk Reduction and Management Fund (LDRRMF) to support programs, projects, and activities that prevent, mitigate, prepare for, respond to, and recover from disasters.

On March 28, 2025, the Provincial Disaster Risk Reduction and Management Council (PDRRMC) of Isabela convened and approved **Council Resolution No. 02-2025**, authorizing the reprogramming of unexpended LDRRMF balances from FY 2021 to FY 2024 amounting to **P486,936,676.69** to augment the implementation of the **2025 LDRRMF Investment Plan**.

This reprogramming is consistent with the provision under Republic Act No. 10121, which states:

*“Unexpended LDRRMF shall accrue to a special trust fund solely for the purpose of supporting disaster risk reduction and management activities of the LDRRMCs within the next five (5) years. Any such amount still not fully utilized after five (5) years shall revert back to the general fund and will be available for other social services to be identified by the local sanggunian.”*

Given the strategic importance of this augmentation in furthering Isabela’s disaster risk reduction efforts and the availability of unexpended funds identified by the PDRRMC, the immediate passage of this ordinance is earnestly sought.

**Section 1. Coverage.** This Ordinance shall cover the reprogramming of unexpended balances from the LDRRMF of the Provincial Government of Isabela for fiscal years 2021, 2022, 2023, and 2024 as detailed in Section 2 hereof.

**Section 2. Reprogramming of Funds.** The following unexpended LDRRMF balances are hereby reprogrammed to augment the 2025 LDRRMF Investment Plan of the Provincial Government of Isabela:

**Section 3. Utilization of Funds.** The utilization of the reprogrammed amount shall be in accordance with the approved 2025 LDRRMF Investment Plan and shall strictly adhere to all applicable government budgeting, accounting, and auditing laws, rules, and regulations.

**Section 4. Authority to Reprogram.** To ensure the responsiveness of disaster risk reduction and management programs and the alignment of fiscal priorities with emerging needs, the Provincial Governor is hereby authorized to augment or reprogram any item from the reprogrammed funds herein provided, within the same appropriation, subject to existing laws and ordinances.

**Section 5. Effectivity.** This Ordinance shall take effect immediately upon its approval.




