WHEREAS, the Provincial Government of Isabela recognizes the critical need to align local development initiatives with national programs to ensure synergized efforts toward resilience building and sustainable development in disaster-prone and underserved communities;

WHEREAS, the Department of Social Welfare and Development (DSWD) has initiated Project Local Adaptation to Water Access (Project LAWA) to strengthen water access for communities and Breaking Insufficiency Nutritious Harvesting for Impoverished (Project BINHI) to enhance food security and combat malnutrition through the Risk Resiliency Program utilizing Cash-for-Work and Training mechanisms;

WHEREAS, these programs are designed to strengthen the resilience, adaptive capacity, and response capabilities of impoverished families in the municipality of Echague, Isabela, by providing additional income support while addressing critical water and food security challenges;

WHEREAS, the Department of Social Welfare and Development Field Office 02 (DSWD FO2) has proposed to enter into a tripartite Memorandum of Agreement with the PGI, and with the Municipal Local Government Unit of Echague, Isabela (MLGU Echague);

WHEREAS, submitted for the review and approval of this Honorable Body is the proposed Memorandum of Agreement between the DSWD, PGI, and MLGU Echague, providing their respective duties and functions on the implementation of the programs aforementioned;

WHEREAS, after a careful review, this Honorable Body deems the aforesaid Memorandum of Agreement to be just, lawful, and promotive of the welfare of the Isabeleños;

WHEREAS, under Section 465 (b)(1)(vi) of the Local Government Code of 1991, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents relative to the execution of his functions, upon authority vested upon him by the Sangguniang Panlalawigan;

WHEREFORE, upon motion of Honorable Maria Katrina Jessica G. Dy, duly approved and seconded in a session duly assembled, it was —
