WHEREAS, Section 80(c) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that:

"The personnel selection board shall be headed by the local chief executive, and its members shall be determined by resolution of the sanggunian concerned. A representative of the Civil Service Commission, if any, and the personnel officer of the local government unit concerned shall be ex officio members of the board."

WHEREAS, pursuant to the above-stated provision, the Sangguniang Panlalawigan of Isabela recognizes its authority and responsibility to determine and approve the composition of the HRMPSB, in harmony with the principles of merit and fitness espoused by the Civil Service Commission and in support of the human resource policies of the Provincial Government;

WHEREAS, Executive Order No. 05, Series of 2025 issued by Governor Rodolfo T. Albano III reorganizes the HRMPSB to comply with the Revised 2018 Omnibus Rules on Appointments and Other Human Resource Actions (ORAOHRA) and to reinforce the standards of transparency, accountability, and professionalism in personnel actions;
