WHEREAS, the Roxas Stand-Alone Senior High School (RSASHS) seeks to establish partnerships with institutions that can provide relevant work immersion opportunities for its students, particularly in the healthcare sector, to equip them with industry-specific knowledge and experience;

WHEREAS, the Manuel A. Roxas District Hospital (MARDH), a healthcare facility owned and controlled by the Provincial Government of Isabela (PGI), is committed to supporting educational initiatives that contribute to the development of future professionals;

WHEREAS, the PGI, under the leadership of Honorable Rodolfo T. Albano III, recognizes the importance of fostering collaboration between educational institutions and public hospitals to enhance students' learning experiences and career readiness;

WHEREAS, to formalize a partnership and ensure the proper implementation of the Work Immersion Program at the MARDH, there is a need to authorize the Governor to enter into a Memorandum of Agreement (MOA) with the Roxas Stand-Alone Senior High School;

WHEREAS, submitted for the review and approval of this Honorable Body is the proposed Memorandum of Agreement between the PGI and the RSASHS, providing for their respective duties and functions on the implementation of the Work Immersion Partnership Program;

WHEREAS, under Section 465, (b) (1) (vi) of R. A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, after a careful review of the said MOA, this Body deems it beneficial and advantageous for the Province to grant the Governor the necessary authority to sign the Memorandum of Agreement on behalf of the PGI;

WHEREFORE, premises considered, upon motion of the Honorable Mary Grace D. Arreola, duly approved and seconded in a session duly assembled, it was –
