WHEREAS, the Department of Social Welfare and Development (DSWD), as the primary government agency responsible for the protection of the social welfare rights of Filipinos, implements the Assistance to Individuals in Crisis Situation (AICS) Program to provide immediate support to qualified beneficiaries;

WHEREAS, the DSWD Field Office 02 has proposed a Memorandum of Agreement (MOA) with the PGI to establish a cooperation mechanism ensuring the efficient implementation of the AICS Program within the province;

WHEREAS, the PGI recognizes the importance of collaborating with DSWD to strengthen the provision of assistance to individuals and families in crisis and improve the overall welfare of the Province's constituents;

WHEREAS, to formalize this partnership and ensure the proper implementation of the AICS Program, there is a need to authorize the Governor to enter into a Memorandum of Agreement (MOA) with the DSWD Field Office 02;

WHEREAS, the proposed Memorandum of Agreement, detailing the respective duties and functions of the PGI and DSWD in implementing the AICS Program, has been submitted to this Honorable Body for review and approval;

WHEREAS, under Section 465, (b) (1) (vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, after careful review, this Body deems it beneficial and advantageous for the Province to grant the Governor the necessary authority to sign the aforesaid Memorandum of Agreement on behalf of the Provincial Government of Isabela;

**NOW, THEREFORE**, upon motion of the Honorable Maria Katrina Jessica G. Dy, duly seconded and approved in a session duly assembled it was –
