WHEREAS, the Department of Social Welfare and Development (DSWD) is a national government agency mandated to local government units, non-governmental organizations, other national government agencies, people's organizations, and members of Civil Society in effectively implementing programs, projects and services that will alleviate poverty and empower disadvantaged individuals, families, and communities for an improved quality of life;

WHEREAS, Memorandum Circular No. 04, Series of 2024 was issued by the DSWD which provides for the "Guidelines in the Implementation of the Ayuda sa Kapos ang Kita Program (AKAP)." AKAP targets social assistance to individuals who may not have access to regular assistance on account of them not belonging to the poorest population. The Program also intends to provide a menu of assistance for goods and services that are affected by high inflation depending on the needs of the individuals;

WHEREAS, under Section 17 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the local government units are mandated to discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to the aforesaid Code. LGUs shall exercise such powers and discharge the functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities enumerated therein;

WHEREAS, for the proper implementation of the AKAP, it requires the execution of a Memorandum of Agreement between the PGI and the Department of Social Welfare and Development (DSWD) which will capture the terms of the cooperation mechanism of the program for an effective and efficient delivery to its qualified beneficiaries;

WHEREAS, under Section 465 (b) (vi) of R. A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREFORE, premises considered, upon motion of the Honorable Maria Katrina Jessica G. Dy, duly approved and seconded in a session duly assembled, it was –

RESOLVED, AS IT IS HEREBY RESOLVED, TO PASS A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR, RODOLFO T. ALBANO III, ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA, TO ENTER, SIGN AND EXECUTE A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT FOR THE IMPLEMENTATION OF THE AYUDA SA KAPOS ANG KITA PROGRAM (AKAP).
