WHEREAS, Republic Act No. 10121, otherwise known as the *Philippine Disaster Risk Reduction and Management Act of 2010*, mandates the allocation of not less than five percent (5%) of the estimated revenue from regular sources as the Local Disaster Risk Reduction and Management Fund (LDRRMF) to support risk reduction and management activities, including pre-disaster preparedness programs such as training and the purchase of rescue equipment, as well as post-disaster activities;

WHEREAS, Section 21 of the said Act further provides that thirty percent (30%) of the LDRRMF shall be allocated as Quick Response Fund (QRF) for relief and recovery programs to normalize living conditions in disaster-affected communities as quickly as possible, while seventy percent (70%) shall be utilized for prevention, mitigation, preparedness, response, and rehabilitation;

WHEREAS, it is the policy of the Provincial Government of Isabela to prioritize disaster preparedness, climate resilience, and the protection of lives and livelihoods through the timely allocation and effective utilization of disaster risk reduction and management resources, in line with its thrust to build a safe, adaptive, and disaster-resilient Isabela;

WHEREAS, the Provincial Disaster Risk Reduction and Management Council (PDRRMC) of the Provincial Government of Isabela (PGI), during its 1st Quarter Regular Council Meeting held on March 28, 2025, at the Emergency Operations Center, PDRRMC-BFP Building, Provincial Capitol, Alibagu, City of Ilagan, Isabela, approved **Council Resolution No. 01-2025**;

WHEREAS, said Council Resolution approved the 2025 Local Disaster Risk Reduction and Management Fund (LDRRMF) Investment Plan of the Provincial Government of Isabela, covering the total amount of P284,549,423.00, representing five percent (5%) of the estimated revenue from regular sources of the provincial government for Fiscal Year 2025;

WHEREAS, the said Investment Plan also includes the reprogramming and utilization of P486,936,676.69 in unexpended LDRRM funds from Fiscal Years 2012 to 2024, as endorsed by the Provincial DRRM Officer and duly approved by the PDRRMC;

WHEREAS, the LDRRMF Investment Plan includes allocations for the Quick Response Fund (QRF), intended for relief and recovery programs to restore normalcy in disaster-affected communities, as well as programs on prevention, mitigation, preparedness, response, rehabilitation, and recovery;

WHEREAS, the PGI LDRRMF Investment Plan for 2025 has been provided with an allocation in accordance with the 30%-70% requirement under Section 21 of Republic Act No. 10121, with **P85,364,826.90** allocated for the **Quick Response Fund (QRF)**, and the remaining **P199,184,596.10** allocated for **Prevention and Mitigation, Preparedness, Response, Rehabilitation, and Recovery Programs**, distributed as follows:

- I. **Quick Respond Fund - P85,364,826.90**
- II. **Prevention and Mitigation, Preparedness, Response, Rehabilitation and Recovery**
 - A. **Maintenance and Other Operating Expenses – P78,134,596.10**
 - B. **Capital Outlay**
 - o Flood Mitigation – P100,000,000.00
 - o Other Rescue Equipment – P5,000,000.00
