**WHEREAS**, Appropriation Ordinance No. 2024-011, an ordinance approving Supplemental Budget No. 06, Calendar Year 2024, of the Local Government Unit of Echague, Isabela, appropriating the amount of **SIXTEEN MILLION EIGHT HUNDRED ELEVEN THOUSAND NINE HUNDRED SEVENTY THREE PESOS & 77/100 (P16,811,973.77)** derived from PS savings of vacant positions and savings from previous years for Terminal Leave Benefits and additional fund for MOOE of the Municipal Mayor's Office and Municipal Engineer's Office, Municipality of Echague, Isabela, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 2024-011 (2024 Supplemental Budget No. 06) of the Municipality of Echague, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

1. The utilization of Terminal Leave Benefits shall be in accordance with CSC Omnibus Rules on Leave pursuant to CSC MC No. 41 s. 1998, BC 2013-1 dated April 12, 2013, BC No. 2016-2 dated March 29, 2016;
2. The appropriation provided for "Other Maintenance and Operating Expenses" shall only be used to record expenses not falling under any of the specific maintenance and other operating expense accounts;
3. That all procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations.

**RESOLVED FURTHER**, to require the Municipality of Echague, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.

**RESOLVED FURTHERMORE**, to inform the Municipality of Echague, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

**RESOLVED FINALLY**, to furnish a copy of this Resolution to the **Honorable FRANCIS FAUSTINO A. DY**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Echague, Isabela through the **Honorable KIRYLL S. BELLO**, Municipal Vice-Mayor.
