WHEREAS, pursuant to Republic Act No. 7160 or the Local Government Code empowers each local government units to establish their own sources of revenue and encourages them to maximize the use of their resources, including the leasing of government properties to private parties, subject to existing laws, rules, and regulations;

WHEREAS, the Provincial Government of Isabela is the owner of the leased premises located at the Provincial Capitol Grounds, Alibagu, City of Ilagan, Isabela;

WHEREAS, Ms. Vilma P. Matalang, a private individual and a resident of City of Ilagan, Isabela has expressed her intent to lease the aforementioned stall for the purpose of operating exclusively as a Tea Cart Business;

WHEREAS, the lease of the said stall will generate revenue for the Provincial Government of Isabela while promoting small business development and contributing to local economic growth;

WHEREAS, this initiative aligns with the policy of the Provincial Government of Isabela to support and provide opportunities for entrepreneurial growth among its constituents;

WHEREAS, to ensure the smooth commencement and operation of the Tea Cart Business, it is essential to execute a Contract of Lease for a period agreed upon by the parties;

WHERAS, Ms. Matalang agreed to pay the monthly rental of Two Thousand Pesos (P2,000.00), inclusive of water and electricity charges, which shall be payable to the Provincial Treasurer's Office on a monthly basis;

WHEREAS, pursuant to Section 465(b)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Provincial Governor is authorized to represent the Province in all its business transactions and sign on its behalf all contracts and documents, subject to the prior authorization of the Sangguniang Panlalawigan;

WHEREAS, this August Body deems it beneficial and in the best interest of the Province to grant the Provincial Governor the necessary authority to sign the Contract of Lease on behalf of the Provincial Government of Isabela;

WHEREFORE, upon motion of Honorable Clifford R. Raspado, duly approved and seconded in a session duly assembled, it was —
