WHEREAS, MCNP has consistently produced competent graduates who contribute to the local healthcare system, demonstrating the effectiveness of academic-practical collaborations in enhancing the competency of future nursing professionals;

WHEREAS, the nursing affiliates of MCNP intends to undergo a Related Learning Experience (RLE) or Practicum in the Milagros Albano District Hospital (MADH), a government hospital owned and supervised by the Provincial Government of Isabela (PGI). To allow free access and use of facilities, equipment, apparatuses and other paraphernalia of MADH by the nursing students of MCNP, a Memorandum of Agreement between the parties is in place;

WHEREAS, submitted for review and approval of this Honorable Body, a Memorandum of Agreement between the PGI and the Medical Colleges of Northern Philippines to facilitate this collaboration, ensuring that nursing students receive proper exposure to real-world medical settings in compliance with the highest standards of nursing education;

WHEREAS, after careful review, this Honorable Body deems the Memorandum of Agreement between the Provincial Government of Isabela and Medical Colleges of Northern Philippines to be just, lawful, and promotive of the health and policies of the PGI;

WHEREAS, under Section 465, (b) (1) (vi) of R.A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREFORE, premises considered, upon motion of the Honorable Victor G. Dy duly approved and seconded in a session duly assembled, it was –
