WHEREAS, in response to increasing risk and exposure to hazards, exacerbated by climate change including the El Niño/La Niña Phenomenon there is a need to implement programs that will ensure maximum care, assistance and services to individuals and families to lessen the impact of disaster and facilitate resumption of normal and social and economic activities;

WHEREAS, the Risk Resiliency Program of the DSWD is a climate change adaptation and mitigation initiative aimed at strengthening the resilience of vulnerable families and communities against socio-environmental risks. Using a convergent approach, the program combines cash-for-work opportunities with training focused on key areas such as food security, water sufficiency, and environmental sustainability;

WHEREAS, one of the key projects under the Risk Resiliency Program is Project LAWA at BINHI or Local Adaptation to Water Access and Breaking Insufficiency through Nutritious Harvest Impoverished which focuses on strengthening communities' ability to withstand the tides of climate change by ensuring water access and promoting climate-smart agriculture;

WHEREAS, the Municipality of Quirino has a total of five hundred (500) target eligible beneficiaries, out of the two thousand one hundred (2,100) total target physical allocation of the province, with total budget allocation of Eighteen Million Nine Hundred Thousand Pesos (P 18,900,000.00) from DSWD Fund;

WHEREAS, under Section 465, (b) (vi) of R.A. 7160, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province of Isabela to grant the Governor the necessary authority to enter, sign and execute the Tripartite Memorandum of Agreement for the full implementation of the Project LAWA at BINHI in the Municipality of Quirino, Isabela; `

WHEREFORE, premises considered, upon motion of the Honorable Maria Katrina Jessica G. Dy, duly approved and seconded in a session duly assembled, it was –
