WHEREAS, the said academic program requires its midwifery students to undergo a Related Learning Experience (RLE) as part of the curriculum, which is necessary for the completion of their course and a prerequisite to their eligibility to take the government licensure examination for midwives;

WHEREAS, to fulfill this academic requirement, the Isabela State University – City of Ilagan Campus seeks the support of the Provincial Government of Isabela through a formal Contract of Affiliation that will grant its students access to certain PGI-managed medical facilities, structures, and specific programs, thereby providing them with practical exposure and experience in actual midwifery work;

WHEREAS, this collaboration is seen as mutually beneficial as it will assist ISU in producing well-trained, competent midwifery graduates while also supporting the PGI's efforts to develop a strong and skilled local health workforce;

WHEREAS, submitted for the review and approval of this Honorable Body is the proposed Contract of Affiliation between the Provincial Government of Isabela and Isabela State University relative to the subject referred to in the two previous clauses;

WHEREAS, after careful review, this Honorable Body deems the Contract of Affiliation between the PGI and Isabela State University to be just, lawful, and promotive of the health policies of the PGI;

WHEREAS, Section 465 (b)(1)(vi) of R.A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign contracts and such other documents relative to the execution of his functions, upon the authority vested upon him by the Sangguniang Panlalawigan;

WHEREFORE, upon motion of the Honorable Emmanuel Joselito B. Añes, duly seconded in a session duly assembled, it was –

RESOLVED, AS IT IS HEREBY RESOLVED, TO PASS A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR, RODOLFO T.
