THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2024-012 (2024 Supplemental Budget No. 07) of the Municipality of Echague, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

- 1. The appropriation for the grant of Service Recognition Incentive (SRI) in the amount of Five Million One Hundred Seventy Five Thousand Pesos (P5,175,000.00) shall be in accordance with AO No. 27 dated December 12, 2024 and DBM Budget Circular No. 2024-7, dated December 16, 2024. Further, the proper account code for SRI should be Other Personnel Benefits, 5-01-04-990;
- 2. The grant of Economic Relief Assistance (ERA) to job order and contract of service workers in the amount of Three Million Three Hundred Five Thousand Pesos (P3,305,000.00) shall be covered with appropriate guidelines and legal basis for its grant;

RESOLVED FURTHER, to require the Municipality of Echague, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.

RESOLVED FURTHERMORE, to inform the Municipality of Echague, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable FRANCIS FAUSTINO A. DY**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Echauge, Isabela through **Honorable ALLAN P. TUPONG**, Municipal Vice-Mayor.
