A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 447-2024 (SUPPLEMENTAL BUDGET NO. 10 FY 2024) IN THE AMOUNT OF SIX MILLION TWO HUNDRED TWENTY FIVE THOUSAND NINE HUNDRED TWENTY THREE PESOS & 83/100 (P6,225,923.83) OF THE MUNICIPALITY OF AURORA, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO CONDITIONS

WHEREAS, Appropriation Ordinance No. 447-2024, an Ordinance authorizing Supplemental Budget No. 10 Calendar Year 2024 in the amount of **SIX MILLION TWO HUNDRED TWENTY FIVE THOUSAND NINE HUNDRED TWENTY THREE PESOS & 83/100 (P6,225,923.83)** reprogramming the balance of 20% Development Fund – Continuing Appropriations for the Installation of electrical system and water supply system at Solid Waste Management Facility located at Kalabaza, Aurora, Isabela, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

RESOLVED, to declare Appropriation Ordinance No. 447-2024 of the Municipality of Aurora, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following condition:

1. The appropriation and utilization of the 20% Development Fund shall be subject to the pertinent provisions of DBM-DOF-DILG Joint Memorandum Circular No. 1 dated November 4, 2020;
2. That the appropriation for the following accounts should be properly classified to its specific Object of Expenditures and Account Code in accordance with COA Circular No. 2015-009 dated December 1, 2015, on Prescribing the Revised Chart of Accounts for LGUs:

3. That all procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations.

RESOLVED FURTHER, to require the Municipality of Aurora, Isabela to comply with the herein conditions.

RESOLVED FURTHERMORE, to inform the Municipality of Aurora, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.
