THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 459-2024 of the Municipality of Aurora, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following condition:

1. The appropriation for the grant of Service Recognition Incentive (SRI) in the amount of One Million Five Hundred Eighty Six Thousand Pesos (P1,586,000.00) shall be in accordance with AO No. 27 dated December 12, 2024 and DBM Budget Circular No. 2024-7, dated December 16, 2024.

RESOLVED FURTHER, to require the Municipality of Aurora, Isabela to comply with the herein conditions.

RESOLVED FURTHERMORE, to inform the Municipality of Aurora, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.


